1. Applications are invited for the Entrance Examination for admission to Post Graduate Degree Courses in Pharmacy 2005 at the College of Pharmaceutical Sciences, Medical College, Thiruvananthapuram, in the following specialties.

(a) Pharmaceutical Analysis (b) Pharmacognosy & Phyto-chemistry
(c) Pharmaceutics (d) Pharmacology (e) Pharmacy practice (f) Pharmaceutical Chemistry

2. **Eligibility for Admission**

- (i) **Nativity:** Indian citizen of Kerala origin
- (ii) **Academic qualifications:** Pass in B.Pharm Degree of Kerala University or equivalent thereto, with at least Second Class and 55% marks in aggregate. Candidates appeared/appearing for final year B.Pharm examination are also eligible subject to their passing examination on date of declaration of entrance examination result.

3. **Selection:** Based on **Entrance Examination** (except for seats reserved for Lecturer in Pharmacy and sponsored candidates) to be conducted by the Commissioner for Entrance Examinations, Kerala on 30.12.2006 (Saturday) at Thiruvananthapuram. The examinations will consist of one paper of three hours duration with 200 objective (multiple choices) questions.

4. **Application forms & Prospectus.** will be available in the website at "**cee-kerala.org**" of the Commissioner for Entrance Examinations, Kerala.

5. **Application fee** (in case of general candidate) **Rs.800/-** (Rupees Eight hundred only) as demand draft drawn in favour of Commissioner for Entrance Examinations payable at Thiruvananthapuram

(in case of service sponsored candidates) Rs.800/- (Rupees Eight hundred only) to be remitted in the Treasury under the Head of Account "**0210-03-105-99**".

Service candidates also applying under General merit seat should forward the original application to the Commissioner for Entrance Examinations with Demand Draft for Rs.800/- and should submit a copy of the application form to the Director of Medical Education with Chalan receipt for Rs.800/-

6. **Last date and time for receipt of filled-in application forms:** Application complete in all respects to be forwarded to (in case of general candidate) the **Commissioner for Entrance Examinations, , Housing Board Buildings, 5^h**

floor, Santhinagar, Thiruvananthapuram-01, either by registered post/hand delivery so as to reach him on or **before 5 pm on 20.12.2006**.

(in case of service/sponsored candidates) To reach the Director of Medical Education, Medical College Campus, Thiruvananthapuram 695 001 on or before 5 pm on 20.12.2006 through their department heads.
