Amendment to the prospectus for admission to Professional Degree Course - 2007

15.1 Allotment of seats from the State Rank List to self- financing Colleges referred to in G.O. (MS) No. 97 /2007/H.Edn. Dated, Thiruvananthapuram, 09.07.2007, will be made as per the provisions contained therein. Fifty per cent (50%) of the total seats in these Private Self Financing colleges/institutions will be available to the government for allotment through the Single Window System [SWS] and will be filled up by the Commissioner for Entrance Examinations from the list prepared the CEE.

15.2.1 The 50% seats to be allotted by the CEE in Private Self- financing Professional Colleges other than those having minority benefits will be distributed among the various categories as follows:

(a) General Merit : 57%

(i) Merit: 30% of 57%

*(ii) Merit cum means: 70% of 57%

Note: *All candidates will be considered for allotment under 'Merit' category of General Merit. However, only candidates whose annual family income is up to Rs.2,50,000/- will be considered for allotment under 'merit cum means' category of General Merit.

(b) Socially & Educationally Backward Communities (SEBC) : 25%

(c) (i) Ezhava (EZ) - 9%

(ii) Muslim (MU) - 8%

(iii) Other Backward Hindu (BH) - 5%

(iv) Latin Catholic Other than Anglo Indian (LC)- 2%

(v) Other Backward Christian (BX) - 1%

(c) SC/ST : 10%

(i) Scheduled Castes (SC) - 8%

(ii) Scheduled Tribes (ST) - 2%

(d) Economically Backward Belonging to Forward Communities : 5%

Candidates belonging to communities which do not come under SEBC/SC/ST/OEC and whose annual family income is up to Rs. 2.5 Lakhs alone are eligible under Category (d) above. Such candidates will have to produce Income and Community certificates to the Commissioner for Entrance Examinations within the time limit notified by the CEE.

(e) Arts / Sports/Persons with Disabilities [1% each] : 3%

Proficiency in Arts: Those candidates who have secured 'A' grade in the State level Youth Festival conducted by Directorates of Higher Secondary Education, Vocational

Higher Secondary Education and Technical Higher Secondary Education of the Government of Kerala alone are eligible for reservation under the 'Arts' category of item (e) above. Candidates desirous of being considered for reservation under this category will have to produce copy of the **relevant** certificate(s) showing the Grade obtained, attested by a Gazetted Officer within the time limit notified by the CEE.

Sports (SP) / Persons with disabilities (PWD): Allotment to these categories will be done from the Category list published by the Commissioner for Entrance Examinations and as per provisions under clauses 5.2.24 & 5.3 of the Prospectus.

15.2.2: Twenty per cent (20%) the total seats set apart to Government for allotment in Private Self Financing institutions having minority benefits, as approved vide G.O (MS) No.97/2007/H.Edn.,Thiruvananthapuram, dated: 09.07.2007, will be allotted to the candidates belonging to the minority community to which the management of the colleges/institutions belongs, on "merit cum means" basis. The list of colleges under this category and the community of the candidates eligible to be considered for allotment to each college are given as **Annexure -XXIII**. Candidates desirous of being considered against such seats whose annual family income do not exceed **Rs. 2.5 lakhs**, should submit to CEE, the income and community certificates from Revenue authorities on or before the date notified by the CEE. The remaining 80% of the seats will be allotted as per the provisions in Clause 15.2.1.

15.3 Distribution of seats in Self Financing Colleges/Institutions sponsored by Government

15.3.1 The distribution of seats in Self-financing Professional Colleges run by institutions under Government control (IHRD, LBS, CAPE, CCE), University of Kerala and MG University will be as follows:

15.3.2 Out of the total seats, 15% will be allotted by the managements concerned and the remaining 85% will be allotted by the Commissioner for Entrance Examinations from the rank list prepared by the CEE, as follows:

(A) Management Quota (Merit)		: 35 %

15.3.3 In the case of Calicut University Institute of Engineering & Technology, Malappuram, 50% of the total seats will be filled up by the CEE as per clause 15.3.2 (a) to (e).

15.3.4. In SCT College of Engineering, Thiruvananthapuram, run by KSRTC, 15% of the total seats will be earmarked as NRI seats. Ten per cent (10%) of the seats under the Management quota will be allotted to dependents of employees of KSRTC, by the Management of the institution. The remaining 25% under management quota will be allotted by the CEE. The 50% seats earmarked as Government quota will also be allotted by the CEE as per Clause 15.3.2 (a) to (e).

15.4 **Fee and Interest free refundable deposit**
The Fee and Interest free refundable deposit for the various courses/ category of seats is given in Annexure XXIV.

15.4.1 **Caution Deposit:**

(i) All Candidates except those belonging to SC/ST/OEC categories will have to remit Caution Deposit at the rates mentioned below.

(a) For MBBS and BDS Courses - A maximum of **Rs. 10,000/-**.

(b) For all other courses - A maximum of **Rs. 5,000/-**.

(ii) **Caution Deposit** for SC/ST/OEC candidates: Candidates belonging to SC/ST/OEC categories will have to remit Caution Deposit at the rates existing in Government Colleges and applicable to the course to which the candidate is allotted.

15.4.2 **Mode of payment of Tuition Fee, Caution Deposit and Interest Free Refundable Deposit [IFRD]**

(a) All candidates except those belonging to SC/ST/OEC categories will have to remit the tuition fee and Interest Free Refundable Deposit in selected branches of the Canara Bank as per the schedule for remittance of fee notified by the CEE. They will have to remit the Caution Deposit in the college at the time of admission. **Candidates who do not remit the tuition fee and IFRD, within the time notified, will lose their allotments and will not be considered for further allotments in that stream.**

(b) Candidates belonging to SC/ST/OEC categories will have to remit the Caution Deposit in selected branches of the Canara Bank at the rates mentioned under clause 15.4.1 (ii), on the dates of remittance of fee notified by the CEE, as a token of having accepted the allotment. SC/ST/OEC candidates, who do not remit the caution deposit within the

stipulated time, will lose their allotments and they will not be considered for any further allotments in that stream.

16 Non Keralite Category II

Candidates who do not come under 'Keralite' or 'Non Keralite' (Category I) will be categorized as 'Non Keralite (Category II). They are eligible for admission to Private Self Financing Engineering Colleges and to Management seats in Government Supported Self- financing Colleges only. Such candidates are not eligible for admission to the Engineering courses in Government/Aided/KAU Engineering Colleges and the Government quota seats in Govt Supported self- financing Colleges or to Medical/Agriculture and Allied courses in Govt. / Aided /KAU/Self Financing Colleges.

17 Lapsed seats

Lapsed seats are those Government seats in Self Financing Colleges that may be filled by the institutions themselves if and when the Commissioner for Entrance Examinations informs that he/she would not be advising any more candidates against such seats.

The Prospectus for Admission to Professional Degree Courses, Kerala, stands modified accordingly.
