KEAM 2013 - ADMISSION TO PROFESSIONAL DEGREE COURSES SECOND PHASE OF ALLOTMENT

The second phase of allotment for admission to professional degree courses 2013 begins on 11.07.2013. The candidates who have already received allotment in the previous allotment can re-arrange / delete their higher options and also register fresh options to newly added colleges from 11.07.2013 to 12.07.2013, 3 pm, through the website www.cee.kerala.gov.in. On the basis of options received upto 3.00 pm on 12.07.2013, the second phase allotment will be published on 13.07.2013. Candidates who receive the second allotment shall take a print out of their allotment memo and remit the fees/ balance fees payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on 15.07.2013, 16.07.2013 or 17.07.2013. The list of designated branches of SBT is available on the website.

All candidates who receive allotment through the Centralised Allotment Process (CAP) should join the allotted colleges from 15.07.2013 to 17.07.2013. They should report for admission to the principal of the allotted colleges along with a print out of their second phase allotment memo, Data Sheet of KEAM 2013 and originals of all documents specified in Clause 11.7.1 of the prospectus. Balance fees to be remitted in the college, if any, should be remitted at the time of admission.

The Principals of colleges should forward the non-joining report to the office of the Commissioner for Entrance Examinations online and its signed printout by fax before 5.30 pm on 19.07.2013 without fail.

The detailed schedule for the 2nd phase of allotment is furnished below.

11.07.2013, 12.07.2013	Website opens for enabling re-arrangement / deletion of higher options and registration of fresh options to newly added college.
12.07.2013 (3.00 pm)	Time for re-arrangement/deletion /addition of option ends
13.07.2013	Publication of Second Phase Allotment (Final Allotment in respect of Private Self financing Engineering Colleges)
15.07.2013 to 17.07.2013	Candidates who have received allotment should remit the fees /balance fees payable in SBT and should report to the principal of the allotted colleges along with original documents, take admission and remit balance fee at the college, if any.
19.07.2013 (5.30 pm)	Principals of colleges to forward the non-joining report online and its signed print out to the office of the CEE by fax

The candidates who fail to join the allotted colleges on the scheduled dates will lose their allotment and all their higher options. They will be removed from the entire allotment process.

Candidates who got allotment to the Private Self Financing Engineering Colleges in the Second Phase of Allotment and those who remit fees and eventually do not take admission in the colleges will be penalised as envisaged in Clause 12.2.4(c) of the Prospectus.
