**KEAM 2014 SECOND PHASE OF ALLOTMENT TO
PROFESSIONAL DEGREE COURSES**

The activities related to the second phase of allotment for admission to Professional Degree Courses 2014 will begin on 15.07.2014. The candidates can re-arrange / delete their higher options and also register fresh options to newly added Colleges/Courses from 15.07.2014 to 17.07.2014, 5 pm, through the website www.cee.kerala.gov.in. On the basis of options received upto 5 pm on 17.07.2014, the second phase allotment will be published on 19.07.2014. Candidates who receive allotment shall take a printout of their allotment memo and remit the fees/ balance fees payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on 21.07.2014 or 22.07.2014. The list of designated branches of SBT is available on the website.

The detailed schedule for the 2nd phase of allotment is furnished below.

Second phase allotment will be made to all courses except MBBS/BDS courses. Those who get allotment should pay only the fee/balance fee. They need not join the college during the Second phase of allotment. The Colleges and Courses for which fresh options can be registered in the 2nd phase of allotment are furnished below:

The Candidates who have been allotted to courses other than MBBS/BDS and who want to cancel their allotments received in the 1st phase of allotment can make use of the **“Proforma for Cancellation of Allotment”** available in the website www.cee-kerala.org. Such students should take a printout of the proforma, fill up the proforma, paste a photograph in the space provided and get it attested by a Govt. Gazetted Officer. After completing this procedure, the candidate himself/herself should produce the filled up proforma at the Office of the Commissioner for Entrance Examinations before 5 pm on 17.07.2014. Request for cancellation of allotments received via post/e-mail/fax will not be considered. Students who cancel their allotments will be removed from the online allotment process for the existing colleges/courses.

The Candidates who have been allotted to MBBS/BDS courses and who have been admitted in the said courses can relinquish the course, if needed, by approaching the college

authorities concerned. Such vacancies should be reported to the Office of the Commissioner for Entrance Examinations by the college authorities before 5 pm on 17.07.2014. The students who cancel their admissions will also be removed from the online allotment process for the existing courses/colleges.

The third round of Allotment will be published on **23.07.2014** after excluding the students who do not remit the fees/balance fees after the second round of allotment. No facility for rearranging/deleting the existing options or addition of fresh options will be provided after the second round of allotment. The third round will be the last round of allotment to Govt/Govt. Controlled Self Financing/Private Self Financing Engineering/Architecture Colleges. All the students who have an allotment after the third round should join the course/college concerned. Those who get an allotment in the Private Self Financing Engineering/Architecture colleges should invariably join the colleges. Otherwise the liquidated damages envisaged as per Clause 12.2.4 of the Prospectus shall be imposed on such students.

Note: *All the higher order options of the candidates who get allotment/admission in Private Self Financing Engineering/Architecture Colleges after the Third Phase of Allotment will be deleted.*
