THIRD PHASE OF ALLOTMENT TO MBBS/BDS COURSES AND FIFTH PHASE OF ALLOTMENT TO OTHER MEDICAL & ALLIED COURSES - 2014

The activities related to the Third phase of Allotment to MBBS/BDS Courses and Fifth phase of Allotment to other Medical & Allied courses for the year 2014 will commence from 30.08.2014 (Saturday).

Candidates included in the rank list for MBBS/BDS courses - 2014 can register fresh options to the newly included Private Self Financing Dental Colleges and Candidates included in the Medical Rank List-2014 can register fresh option to the newly included Ayurveda, Homoeopathy and Siddha Medical Colleges through the Website www.cee.kerala.gov.in from 30.08.2014 to 04.09.2014, 4 pm. Candidates who do not register their options within the stipulated time will not be considered for allotment to the newly included colleges under any circumstances. The "Option Facilitation Centres" [OFC] and "Help Desks" [HD], having internet facility, will be functioning throughout the State during this period for providing necessary help to the candidates for registration of options. Token Deposit:

Candidates allotted under SC/ST/OEC Community category and those having benefit as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005, have to remit token deposit at the rates mentioned below, as token of having accepted the allotment:

1. MBBS/BDS courses : Rs. 1000/-2. All Other Courses : Rs. 100/-

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

<u>Note:</u> Candidates admitted in Govt/Govt. Controlled Self Financing/Private Self Financing Engineering Colleges and Private Self Financing Architecture Colleges can accept the new allotment to Medical/Medical Allied Courses only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2014 and orders issued by the Government.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies / Affiliation from the Universities.
