The candidates who have qualified in the Engineering Entrance Examination 2014 were directed to submit the marks obtained for the Subjects concerned in the Second year of Plus Two or equivalent Qualifying Examination through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) from 20.05.2014 to 06.06.2014 and to submit the duly signed copy of Mark Submission Data and attested copies of Plus Two mark sheets on or before 06.06.2014 to the Commissioner for Entrance Examinations for the preparation of Engineering Rank List 2014.

Also the candidates who have applied for admission to B.Arch Courses 2014 were directed to submit the marks obtained for the Subjects concerned in the Second year of Plus Two or equivalent Qualifying Examination along with the NATA Score through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) from 20.05.2014 to 06.06.2014 and to submit the duly signed copy of Mark Submission Data along with attested copies of Plus Two mark sheets and NATA Score Card on or before 06.06.2014 to the Commissioner for Entrance Examinations for the preparation of Architecture Rank List 2014.

Accordingly the marks data submitted by the candidates are now published on the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) for verification. Candidates have to enter their homepage by giving their Roll Number, Application Number and Key Number to see the marks data submitted by them for the preparation of Engineering/Architecture Rank Lists-2014. The Candidates may verify their marks, Board of Qualifying Examination, Register Number, Year of Passing and NATA Score (for B.Arch Course) for ensuring its correctness. Changes, if any, shall be brought to the notice of the Commissioner for Entrance Examinations on or before 5 pm on 09.06.2014 by submitting the proforma available on the candidate's home page by clicking the link "Mark Submission Declaration" along with attested copies of Mark List of Qualifying Examination/NATA Score Card. In the event of changes, if any, in the Mark Data submitted for both Engineering and Architecture, separate "Mark Submission Declaration" Proforma are to be submitted. Requests for changes in marks will not be entertained under any circumstances after 09.06.2014. The marks data as on 09.06.2014 will be used for the preparation of Engineering/Architecture Rank Lists-2014, after considering the genuine complaints, if any, received from the candidates.
