**KEAM 2015: SECOND PHASE OF ALLOTMENT TO  
PROFESSIONAL DEGREE COURSES**

The activities related to the second phase of allotment for admission to Professional Degree Courses 2015 will begin on 04.07.2015. During the second phase, allotment will be done only to Engineering/Architecture courses. The Candidates who want their higher options to be considered for the second phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After Online Option Confirmation, the candidates can re-arrange / delete their higher order options and also register fresh options to newly added Courses/Colleges from 04.07.2015 to 07.07.2015, 10 pm, through the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) . On the basis of options received upto 10 pm on 07.07.2015, the second phase allotment will be published on 09.07.2015. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on any date from 10.07.2015 to 15.07.2015. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, the candidates should join the course/college allotted as per the second phase.

The detailed schedule for the 2<sup>nd</sup> phase of allotment is furnished below.

**SCHEDULE FOR THE SECOND PHASE OF ALLOTMENT**

04.07.2015	Website opens for Online Option Confirmation and for enabling re-arrangement / deletion of higher options and registration of fresh options to newly added Courses/Colleges.
07.07.2015 (10 pm)	Time for Online Option Confirmation and re-arrangement/ deletion /addition of options ends
09.07.2015	<b>Publication of Second Phase Allotment</b>
10.07.2015 to 15.07.2015	Candidates who have received allotment should remit the fee /balance fee payable in SBT and should report before the college authorities to join the allotted college/course.

Those who do not confirm their options online will not be considered for the second phase allotment and also their higher options in Engineering/Architecture streams will not be available in the subsequent phases. However his/her existing allotment shall be retained if he/she has remitted the required fee as per the first phase allotment.
