MBBS/BDS COURSES-2015

ONLINE ALLOTMENT TO FILL UP THE VACANT SEATS
ONLINE OPTION CONFIRMATION IS MANDATORY

The vacant seats in MBBS/BDS courses after the third phase of allotment to MBBS/BDS courses in Govt/Govt Controlled Self Financing/Private Self Financing Medical/Dental colleges will be filled up through an online allotment which will be published on 17.09.2015. The Candidates who want their higher order options to be considered in this vacancy filling phase of allotment shall have to login to their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange /delete their higher order options and also register fresh options to newly added Courses/Colleges from 15.09.2015, 7 pm to 17.09.2015, 3 pm, through the website www.cee.kerala.gov.in. On the basis of options received up to 3 pm on 17.09.2015, the vacancy filling phase of allotment to MBBS/BDS will be published on 17.09.2015. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on 18.09.2015 or 19.09.2015. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, the candidates should join the course/college before 5 pm on 19.09.2015. **Those who do not confirm their options online will not be considered for this phase of allotment.**

The schedule for allotment is given below:

15.09.2015 (7 pm)	Website opens for Online Option Confirmation and for enabling re-arrangement / deletion of higher options and registration of fresh options to newly added Courses/Colleges.
17.09.2015 (3 pm)	Time for Online Option Confirmation and re-arrangement/ deletion /addition of options ends
17.09.2015 (8 pm)	Publication of Allotment
18.09.2015 to 19.09.2015	Candidates who have received allotment should remit the fee /balance fee payable in SBT and should report before the college authorities to join the allotted college/course.
19.09.2015, 5.30 pm	All the college authorities should approve and submit the list of admitted candidates.

* This fee concession benefit will be available to the candidates only after completion of allotment process. Hence candidates should remit the full fee to the Commissioner for Entrance Examinations at the time of allotment. Balance fee will be refunded to the candidates.

Token Deposit :

Candidates allotted under SC/ST/OEC Community category and those having benefit as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005, have to remit token deposit of Rs. 1000/- as token of having accepted the allotment.

This allotment is for filling up the vacant seats in only MBBS/BDS courses and the allotments to other Medical & Allied courses will be notified in due course.

Important:- This will be the last phase of allotment to Govt controlled Self Financing/ Private Self Financing MBBS/BDS Colleges. Hence the candidates who get allotments to such colleges should invariably join the allotted colleges. Otherwise they are liable to pay the Liquidated damages of Rs.10 lakhs as envisaged under Clause 12.2.4 of the Prospectus for KEAM-2015.

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

Note: Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to MBBS/BDS Courses only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to MBBS/BDS Courses subject to the conditions in GO(Ms) No. 252/2014/H.Edn. Dated: 07.06.2014.

The Candidates admitted in other Private Self Financing Engineering/Architecture Colleges who are allotted to Medical & Allied courses through KEAM 2015 need not pay the Liquidated Damages as per GO(Ms) No. 372/2015/H.Edn. Dated: 03.07.2015 and GO(Ms) No.378/2015/H.Edn. Dated: 03.07.2015 for getting Transfer Certificate and other Documents. But the fees remitted for the year shall not be refunded.
