**ONLINE ALLOTMENT TO FILL UP THE VACANT SEATS IN
ENGINEERING/ARCHITECTURE/PHARMACY COURSES, KERALA-2017
ONLINE OPTION CONFIRMATION IS MANDATORY**

The activities related to the online allotment to fill up the vacant seats in Government/Aided/Government Controlled Self Financing Engineering colleges and Government Pharmacy colleges will commence on **01.08.2017 (Tuesday)**.

Candidates included in the Rank Lists for Engineering/Architecture/Pharmacy Courses 2017 and continuing in the Centralised Allotment Process (CAP) will have the facility for **Online Option Confirmation** and can re-arrange their existing higher options and/or delete the unwanted higher options. The higher order options in Engineering, Architecture and Pharmacy courses of those candidates who were allotted and admitted in the Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Management Association and the Private Self Financing Architecture Colleges under Architecture College Management Association in the third phase of allotment have been deleted in accordance with the provisions in the related Government Orders. These candidates will not be considered for the vacancy filling allotment. Similarly, the higher order options in Engineering of those candidates who were allotted to Private Self Financing Engineering Colleges under Kerala Self Financing Engineering College Management Association have been deleted in accordance with the provisions in the related Government Order. But their higher options in Architecture and Pharmacy courses will be retained.

Candidates who want their existing higher order options under Engineering/Architecture/Pharmacy courses to be considered for the online allotment to fill up the vacant seats shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange / delete their higher order options from **01.08.2017 to 03.08.2017, 10 am** through the website www.cee.kerala.gov.in. The allotment on the basis of options existing up to **10 am on 03.08.2017**, will be published on **04.08.2017**. The candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the Commissioner for Entrance Examinations in one of the designated branches of the State Bank of India (SBI) or by way of online payment on or before **08.08.2017**. The list of designated branches of SBI is available on the website. After remitting the fee/balance fee, all the candidates should join the course/college allotted before **5 pm on 08.08.2017**.

The detailed schedule of the vacancy filling allotment is given below:

01.08.2017	Website opens for Online Option Confirmation and for enabling re-arrangement / deletion of higher options.
03.08.2017 - 10 am	Time for Online Option Confirmation and re-arrangement/ deletion of options ends
04.08.2017	Publication of Allotment
05.08.2017 to 08.08.2017	Candidates who receive allotment should remit the fee /balance fee payable in SBI or by way of Online Payment and should report before the college authorities to join the allotted college/course.
08.08.2017 - 5.30 pm	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS).

Those who do not confirm their options online will not be considered for the allotment to fill up the vacant seats in Engineering/Architecture/Pharmacy courses. However, his/her existing allotment shall be retained if he/she has joined the college as per the previous allotment.

The vacancies, if any, remaining after 08.08.2017 in Government/Aided/Government Controlled Self Financing Engineering colleges and Government Pharmacy colleges can be filled up by the respective college authorities through Spot Admission before 15th August 2017.
