ORDER

As per Government Orders read as first to third above, Government accorded sanction for including 34 Self Financing colleges for allotments of students to Bachelor of Pharmacy course for the year 2017. In those orders, the cut off date for allotment of seats under Government merit quota for the academic year 2017-18 was fixed as 15/07/2017.

- 2. As per the letter read as fourth above, the Commissioner for Entrance Examinations (CEE) has reported that the last date for admission to Engineering Courses is scheduled to be on 20.07.2017 and if the cut off date for admission to self-financing pharmacy courses is not re-scheduled to 25.07.2017 the students, who seek admission to the Engineering colleges after opting for the B.Pharm course shall have to pay liquidated damages. Hence CEE have requested to refix the cut off date for filling in the Government merit quota of B. Pharm programme on 25/07/2017.
- 3. Government have examined the matter in detail and are pleased to refix the cut off date for filling in the Government seats of B. Pharm programme in Self-Financing institutions for the academic year 2017-18 as 25/07/2017 with specific instruction that the admission procedures should be completed by 30th July, 2017.
