**MOP-UP COUNSELLING TO MEDICAL & ALLIED COURSES (EXCEPT MBBS, BDS)**  
**ONLINE OPTIONS REGISTRATION- INVITED.**

The Online Option registration for the Mop-up Counselling to Medical & Allied Courses (Except M.B.B.S, BDS) has commenced on **07.09.2019** to fill up the remaining vacant seats. In this phase allotment will be done to other Medical course such as Ayurveda (BAMS), Homoeopathy (BHMS) Sidha, Unani and Allied course such as Agriculture, Forestry, Veterinary and Fisheries courses.

All the Candidates included in the Kerala medical, Ayurveda rank lists can register Options unless otherwise stated. Candidates who want to be considered for the allotment to Medical & Allied Courses (Except M.B.B.S/BDS) shall have to log into their Home page provided in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). by clicking 'Option Registration' button available there in from 07.09.2019 onwards. Candidates can register fresh options from 07.09.2019 to 15.09.2019, 05.00 pm through the above website. The allotment on the basis of options received within the stipulated time will be published on **16.09.2019**. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the Commissioner for Entrance Examinations, at any of the **Head Post Offices in Kerala** or by way of **Online Payment** on any date from **17.09.2019 to 18.09.2019, 5.00 pm**. The list of Post offices having facility for fee payment is available in the website.

Candidates who stand admitted in Ayurveda, Homoeo, Sidha, Unani courses under All India Quota and MBBS, BDS courses as per the State allotment shall not be considered for the Mop-Up Counselling. If the Candidate who has already been admitted to Ayurveda, Homoeo, Sidha, Unani, Agriculture, Forestry, Veterinary and Fisheries courses gets allotment in new colleges through Mop-Up counselling as per option, his/her previous admission will be cancelled.

<b>17.09.2019 to 18.09.2019, 5.00 pm</b>	Candidates who receive allotment should remit the fee/balance fee (if applicable) payable to CEE in any of the Head Post Offices in Kerala or by way of online payment and

	should report before the college authorities to join the allotted college/course .
18.09.2019, 05.30 pm	All the college authorities should approve and submit the list of admitted candidates through Online Admission Management System (OAMS)

**Candidates who do not register their online options are not considered for the Mop-up counselling.**

**Note:**

- 1) Candidates are advised to file options to the courses/colleges to which they are sure to join and continue studies if allotted, at the time of registration of options.
- 2) Candidates giving options to Siddha course must know Arabic/Urdu language.

**Token Deposit :**

Candidates allotted under SC/ST/OEC category and those having benefits as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005 and G.O. (MS) 10/2014/BCDD, dated: 23.05.2014, have no token deposit.

The Spot admission to fill up the vacant seats if any arise after the Online Mop-Up Counselling is scheduled to be held on 20.09.2019, 10.00 am at, Thiruvananthapuram. Detailed Notification for Spot admission will be published later.
