THREE YEAR LLB COURSE 2020-21
ONLINE MOP UP ALLOTMENT

The activities related to the Mop Up Allotment for admission to Three Year LL.B Course in the four Government Law Colleges and Private Self-financing Law Colleges of the State for the year 2020-21 will commence on **17.10.2020 (Saturday)**. Candidates who have figured in the rank list of Three Year LL.B Course 2020 published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per clause 6 in the Prospectus can participate in the Mop Up allotment. Candidates who have got admitted in the previous phases, those who have not got admission after allotment, those who have obtained Transfer Certificate after admission and those who have not yet received any allotment can participate in this Mop Up Allotment process. Candidates can register options to all the courses/colleges to which the candidate wish to join as the newly vacant seats due to transfer of students who have already secured admission, will also be filled in this allotment. Those candidates who have not registered their options within the stipulated time will not be considered for this allotment.

The schedule for the allotment is given below

17.10.2020	Website opens for Option Registration
19.10.2020, 4.00 pm	Time for Option registration ends
20.10.2020	Mop Up Allotment
23.10.2020, 3.00 PM	Last Date for joining the allotted college

Online Option Registration is mandatory in this phase. Candidates who wish to participate in the Mop up Allotment shall have to log on to their home Page provided in the website www.cee.kerala.gov.in by giving their Application Number & Password through the link “Three Year LL.B 2020 - Candidate Portal”. Then by clicking the Menu item Option Registration, candidate can register their options online from 17.10.2020 to 19.10.2020, 4.00 PM

The candidates who get allotment in this phase shall have to join the allotted college with all the original certificates as given in the prospectus clause 18 before **23.10.2020, 3.00 pm** after remitting the fee, if any, to be paid to the Commissioner for Entrance Examinations by way of Online Payment or through any selected Head Post Offices. The balance tuition fee, other fees and the deposits (if applicable) should be remitted in the allotted colleges at the time of admission.

Candidates belonging to SC/ST/OEC/Communities eligible for educational concessions as is given to OEC/Candidates eligible for fee concession as per GO(Ms)No.25/2005/SCSTDD dated: 20.06.2005/Children of Fisherman/Inmates of Sri Chithra home, Nirbhaya home & Juvenile home allotted under Government Quota are exempted from payment of fees.

All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) at **4.00 pm on 23.10.2020**.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 6 of the Prospectus at the time of admission.

Note: The vacancies, if any, remaining in three year LL.B course in government/Self-financing Law colleges after 3.00 Pm on 23.10.2020 shall be filled up through Spot admission to be conducted by the Principals concerned before 31.10.2020, 5.00 PM.
