**ORDER**

In the Government order read as 1<sup>st</sup> paper above, Government have approved the Prospectus for admission to Integrated Five year LLB Course for the year 2013-14. As per the Government Order read as 2<sup>nd</sup> paper above, the last date for admission to the course was extended up to 31.10.2013.

The Commissioner for Entrance Examinations in the letter read above, has informed that even after the final phase of allotment to be done in the 4<sup>th</sup> week of October 2013, merit seats will be remaining vacant in some colleges due to want of options from qualified candidates and non- joining of allotted candidates. He has therefore requested to issue orders authorizing the Principals of Govt. Law Colleges and Self Financing Law Colleges for conducting spot admission to fill up the vacancies.

Government have examined the matter and are pleased to accord sanction to the Principals of Govt. Law Colleges and Self financing Law Colleges for filling up the vacancies in Govt merit seats for Integrated Five year LLB Course 2013-14 in their respective colleges after the final phase of allotment by conducting Spot Admission from the rank list and category list published by the Commissioner for Entrance Examinations before 31.10.2013. The Principals are also directed to conduct the spot admission after giving wide publicity through leading news papers and various mass media and by strictly observing merit and reservation principles as laid down in the Prospectus for Admission to Integrated Five Year LLB Course 2013-14. No admissions shall be made to the course after 31.10.2013, even if vacancies arise thereafter.

The validity of the rank list prepared by the Commissioner for Entrance Examinations for Integrated Five year LLB Course 2013-14 is also extended upto 31.10.2013.
