**ADMISSION TO INTEGRATED FIVE YEAR LL.B COURSE, 2018-19**  
**SECOND PHASE OF ALLOTMENT PUBLISHED**

The second and final phase of Centralised Allotment for admission to Integrated Five Year LL.B Courses in Government Law Colleges and Private Self Financing Law Colleges in the State for the academic year 2018-19 is published herewith in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). The allotment is based on the existing online options as of 5 pm on 20.09.2018.

Candidates can access their homepage by entering their application number, and password in the 'Integrated Five Year LL.B 2018 - Candidate Portal' provided in the website. Then by clicking the menu item 'Allotment Result' candidates can download their allotment memo. The details such as candidate's name, roll number, allotment details, tuition fees, deposit if any etc. are available in the allotment memo. The candidate shall take a print out of the allotment memo. Candidates can log into their Home Page and then click the Menu Item 'Data Sheet' for downloading the Data Sheet.

Candidates who receive allotment should report for admission to the Principal of the allotted colleges on **22.09.2018, 24.09.2018 or 25.09.2018** along with the allotment memo and original documents specified in Clause 18 of the Prospectus. They should remit the complete fees as per Government orders in the allotted college at the time of admission. All the College Principals should approve and submit the list of admitted candidates through Online Admission Management System (OAMS) by **5.30 p.m. on 25.09.2018**.

**Candidates who do not take admission on the specified dates will lose their existing allotment.**

Candidates who receive allotment to their higher options in the second phase of allotment, should get the T.C, relevant documents and amount remitted as tuition fee and refundable deposit at the time of admission from their present colleges and join the newly allotted colleges on the above specified dates, failing which they will lose their current admission also.

**Note:-** The fee amount of Rs.15,000/- and allotment to the Self Financing Law College Bhavan's NA Palkhivala Academy for Advanced Legal Studies & Research is provisional and will be subject to the final order of the Hon'ble High Court of Kerala in WP(C)No.30341/2018.

**Spot Allotment:** The seats remaining vacant, if any, after 25.09.2018 to the Integrated Five Year LL.B Course in the Government/ Private Self Financing Law Colleges shall be filled up through a spot allotment to be conducted by the Commissioner for Entrance Examinations at Thiruvananthapuram on 27.09.2018.
