ADMISSION TO THE PG DENTAL COURSES-2018 MINORITY QUOTA SEATS IN PRIVATE-SELF FINANCING MEDICAL COLLEGES DOCUMENTS TO PROVE MINORITY COMMUNITY INVITED FROM STUDENTS

As per GO (Rt) No. 1117/2018/H&FWD, Dated 03/04/2018, a portion of the PG Dental seats in the Private Self-financing Dental Colleges in the State having minority status have been earmarked for the students belonging to the Minority Community to which the management of the Institution belongs. These seats shall be filled up by the Commissioner for Entrance Examinations from the students belonging to the respective minority Communities during the Second Phase of Counseling.

Candidates who seek admission under Minority quota seats in the Private Self-financing Dental Colleges in the State having Minority status shall have to login to the home page of the candidate through the link “PG Dental 2018-Candidate Portal” provided in the website www.cee.kerala.gov.in and should click the menu item ‘Minority Quota’ available therein. Then a list of Private Self Financing Dental College having Minority Status along with the details of Minority Community, the criteria of eligibility and the documents to be furnished for claiming Minority quota will be displayed. In addition, proforma of the Community Criteria to be submitted in respect of each community category will be available for download against the community concerned. Candidates seeking admission under Minority Quota should obtain the Community Certificate in this prescribed format from the Revenue Officials (as applicable) and should upload the Community Certificate. The last date for submission is 24.04.2018, 5 pm.

Community Certificate issued by the authority designated to issue the certificates alone shall be considered. Defective and incomplete Certificates shall not be considered. Candidates should ensure the Community Certificates are signed by the Authority concerned and proper seal is affixed in it. After verification on the Minority documents, provisional Minority category list will be published in the website of Commissioner for Entrance Examinations. Complaints, if any, with regard to the Provisional list will be invited and the final list will be published prior to the publication of the allotment.
