REVISED NOTIFICATION

ADMISSION TO PG DENTAL (MDS) COURSES, KERALA-2019 MOP-UP COUNSELING TO FILL UP VACANT SEATS

The Mop-Up counseling to fill up the vacant seats in P G Dental (MDS) Courses - 2019 in Government/Self Financing Dental colleges will be conducted at 9.30 am on **07.05.2019** at the **Medical College Campus Old Auditorium, Thiruvananthapuram**. The Mop-up counseling will be done as per the guidelines issued vide **G.O.(Ms)No.50/2019/H&FWD,dated,21.03.2019**.

Eligible candidates included in the Kerala state rank list published by the Commissioner for Entrance Examinations can register for Mop-up counseling through the link '**PG Dental-2019-candidate portal**' provided in the website www.cee.kerala.gov.in and download a Mop-Up Registration slip from the above portal. The facility for registration to Mop-Up round and to download Mop-Up Registration slip will be available in the above website from **04.05.2019 to 06.05.2019, 8 pm**. The **Mop-Up Registration Slip** is mandatory for a candidate to participate in the Mop-Up Counseling process.

Guidelines for Mop-Up Counseling

1. The Mop-Up Counseling will be based on the Kerala State Rank list, published by the Commissioner for Entrance Examinations.
2. The Mop-Up Counseling will be manual and as per the provisions contained in clause 12 of the Prospectus for admission to PG Dental Courses (MDS) 2019. A candidate who figures in the Kerala State Rank list prepared for Admission to PG Dental (MDS) Courses-2019 can attend the Mop-Up Counseling. **Those who are holding All India Quota seats will not be entitled to attend the Mop-Up counseling.**
3. *Candidates who have obtained admission in Government merit seats for a subject in any of the Government Dental Colleges shall not be eligible to participate in the Mop-Up Counseling for the same subject in other Government Dental colleges. Similarly candidates who have obtained admission in a course in any of the Self Financing dental colleges shall not be eligible to participate in the Mop-Up Counseling for the same subject in other Self Financing Dental colleges. However, a candidate who got admission in a Self Financing Dental College shall be permitted to take admission in the same/different subject in a Government Dental College through Mop-Up Counseling and vice-versa.*
4. Transfer from the NRI quota seats to General Quota seats and vice versa are permitted.
5. Candidates (except SC/ST/OEC/Children of Fishermen) getting fresh admission to any Government Dental college through Mop-Up round shall have to produce a **Demand Draft for Rs. 45,000/- (Forty five thousand)** drawn in favour of **Commissioner for Entrance Examinations, payable at Thiruvananthapuram** at the time of allotment. Candidates getting fresh allotment in Private Self Financing College shall have to bring a **Demand Draft for Rs. 3,00,000/- (Three lakhs)** drawn in favour of **Commissioner for Entrance Examinations, payable at Thiruvananthapuram**. Remaining fee shall have to be remitted in the allotted college.

6. SC/ST/OEC/Children of Fishermen/ Inmates of Sri Chitra Home, Nirbhaya Home, Juvenile Home candidates allotted to a Government Dental College or Government seats in Private Self Financing Colleges are exempted from payment of fees. But the SC/ST/OEC/Children of Fishermen/ Inmates of Sri Chitra Home, Nirbhaya Home, Juvenile Home candidates allotted to a seat in NRI/ Minority Community seats in Private Self Financing Dental College shall have to pay the fees fixed for that seat.
7. A candidate who has already paid tuition fees to the CEE during the first or second phase of allotment need to pay only the balance amount, if any, during the Mop-Up Round.
8. All vacant seats reported by the colleges concerned/DME at **5.00 pm on 03.05.2019** due to non-joining / issue of TC will be included at the Mop-Up round scheduled to be conducted on **07.05.2019**. **Course once allotted in the Mop-Up Counseling shall be final**. Mere surrender/Exchange of seat in the Mop Up round will not be allowed.
9. The vacancies created at the time of Mop-Up Counseling will be filled up then and there itself according to merit and eligibility.

Documents in original to be produced at the time of Mop-Up Counseling

1. Mop-Up Registration Slip.
2. NEET-MDS 2019 Score Sheet.
3. Originals of all the Uploaded documents.
4. Document to prove Date of birth.
5. Pass/Degree certificate of the qualifying examination (BDS Degree).
6. Permanent Registration Certificate from Kerala Dental Council & up-to-date Renewal certificate
7. CRRRI Certificate.
8. Certificate of Eligibility/Equivalency certificate from KUHS for candidates who have passed the qualifying examination (BDS Degree) from Universities outside Kerala.
9. Admit card issued by the National Board of Examination, New Delhi.
10. Demand Draft for token amount/Tuition fee to be paid to CEE.
11. Transfer Certificate and Conduct Certificate
12. Any other documents mentioned in the Mop-up registration slip.

NOTE: A candidate who is holding any seat allotted by CEE need to submit the Mop-Up Registration Slip only.

Representatives of all colleges who are competent to issue Transfer Certificate, if necessary are directed to be present at the venue of Mop-Up Counseling at 9.30 am on 07.05.2019 without fail. They are also directed to bring all the original documents collected from the students at the time of 1st and 2nd phases of allotment. The vacant seats in Government/ Private Self Financing Dental Colleges after the second phase of counseling will be published before the Mop-Up counseling.

Important:

- a) The candidates who are allotted with a seat in the Mop-Up counseling and who discontinues the course on any reason after this admission shall be liable to pay the liquidated damages as per Clause 13 of the prospectus for admission to PG Dental Courses 2019.
