ORDER

As per judgement read above, the Hon'ble Supreme court had fixed time schedule for the allotment of seats for the Medical Post Graduate Courses in Government and Self Financing Medical colleges. Now the Commissioner for Entrance Examinations as per letter read above has informed that the allotment and admission to PG Medical Courses are done in accordance with the time schedule fixed by the Hon'ble Supreme Court of India vide reference (1) cited. Accordingly the first phase of allotment was conducted on 15th April 2016 by including the seats in Government Medical Colleges.

The Second phase of allotment was notified as per reference (3) cited by including Government seats in Private Self financing Medical Colleges also and the allotment is scheduled to be conducted on 20th May 2016. But the candidate who are opting for Government Controlled/ Private Self Financing Medical Colleges will get only one opportunity to select the seats in the colleges. Consequently, the managements of Government Controlled/ Private Self Financing Medical colleges will utilize the seats which is vacant after 27.05.2016 as management quota seats. This is possible because of the conditions stipulated in the agreement of Government with Self Financing Medical Colleges. So, in the interest of justice to the candidates, it is better to fix the date of joining of second phase of allotment as 25th May 2016 and to conduct a spot admission to vacant seats in Government/Government Controlled/ Private Self financing Medical Colleges on 27th May 2016 as per the provisions contained in clause 11.1.18 of the prospectus for admission to PG Medical Courses.

Government have examined the matter in detail and are pleased to refix the date of joining in the second phase of allotment as 25.05.2016. The Commissioner for Entrance Examinations is also permitted to conduct a spot admission on 27.05.2016 for the vacant seats in Government/ Government Controlled/ Private Self Financing Medical Colleges.

The last date of joining mentioned in the agreement executed by the Self Financing Medical Colleges also stands modified to the above extent.


