NOTIFICATION

Admission to PG Medical (Degree/Diploma) Courses 2018 Second phase of Allotment Published

The second phase of allotment to PG Medical (Degree/Diploma) courses 2018 to the vacant/enhanced seats and reverted All India Quota Seats in Government Medical Colleges and NRI/Community Quota seats in Private Self Financing Medical Colleges is published herewith.

This allotment is based on the rank in the “Revised Kerala State Rank list” published vide this Office Notification dated 06/05/2018 and the online options filed by the General Quota and inservice candidates from 06/05/2018 to 08/05/2018, 3pm. The allotment list is available in the website of the Commissioner for Entrance Examinations www.cee.kerala.gov.in. To view the allotment result, candidates should log on to the “PG Medical 2018 Candidate portal” by submitting their respective Application number and Password. Clicking on the menu “Allotment result” candidates can view their allotment result. The allotment memo will be made available from 09.05.2018 and it is necessary to take a print out of the allotment memo.

Payment of Fee:

Those candidates who receive an allotment shall have to remit the fees as specified in the allotment memo to the Commissioner for Entrance Examination. The fee can be remitted using the Online Payment facility or at any selected branches of State Bank of India (SBI) (the list of designated branches is available in the website) from 10/05/2018.

SC/ST/OEC/Children of Fishermen candidates are exempted from payment of fees. However they have to pay an amount of Rs.1000/- as token of having accepted the allotment (not applicable for NRI/Minority/Management seats).

Joining Schedule:

The candidates should take admission in the respective Medical College from 09/05/2018 to 11/05/2018 before 5 PM along with the documents and balance fee specified in the Allotment Memo. All the college authorities should approve the list of admitted candidates through Online Admission Management system at 5pm on 12/05/2018.

Conditions of exit after second phase of allotment (GO(Rt) No. 1218/2018/H&FWD dated 12.04.2018)

Those candidates who have joined PG course under State quota on exit, after being allotted to the seats in the second round will have to forfeit 10% of the annual fee if they have not joined the course ie., the exit shall be allowed only on forfeiture of 10% of the total annual fee during the second round and if they have joined the course they will not be eligible for further counseling. In case the applicant retains the seats in the first allotment and he/she is not allotted any seats in the second allotment then this allotment in the first allotment will be considered as equivalent to the seat allotted in second round and he will have to forfeit 10% of annual fee, if he quit before the last date of joining in the second phase of allotment.

Mop-up round of admission will be conducted at Thiruvananthapuram on 14.05.2018:

The detailed notification regarding Mop-up round of admission will be issued later.
