**SECOND PHASE OF ALLOTMENT TO PG NURSING COURSES (MSc Nursing)-2018  
FACILITY FOR ONLINE REGISTRATION/OPTION CONFIRMATION**

As per the G.O (Rt.) No.2970/2018/H&FWD,dated 27.09.2018, the allotment / admission process of M.Sc. Nursing course- 2018 is resheduled.In this regard, there will be a second allotment to fill up the vacant seats that exist after the first phase of allotment. The activities related to the second phase of centralized allotment to Post Graduate Nursing Courses (MSc. Nursing) for the year 2018 will commence from **01.10.2018 (monday)**. This phase of allotment will be done for the vacant seats in Government Nursing colleges and Private Self Financing Colleges including KVM college of Nursing, Cherthala recognised as per the G.O. (Rt.) No.2952/2018/H&FWD , dated 25.09.2018.

Candidates who have already submitted online options and who want to participate in this phase of allotment must compulsorily confirm their existing options by clicking the 'Confirm' button available in his/her home page. After **online option confirmation**, such candidates can delete the unwanted higher options and can re-arrange their existing higher options. In addition, all the eligible candidates can register fresh options to the newly included Private Self Financing Nursing college. The facility for online option confirmation /deletion/re-arrangement/filing of fresh options will be available on the Website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) from **01.10.2018 to 03.10.2018, 5 pm**. **Those who do not confirm their options through online within the stipulated time, will not be considered for this phase of allotment.**

**The schedule for the second phase of allotment is given below:**

<b>01.10.2018</b>	Website opens for enabling online option confirmation/re-arrangement/ deletion of existing options / filing fresh options to the newly included colleges and courses.
<b>03.10.2018 - 5 PM</b>	Facility for online option confirmation/re-arrangement / deletion of options ends.
<b>04.10.2018</b>	<b>Publication of second phase of allotment</b>
<b>05.10.2018 to 08.10.2018, 5 PM</b>	All candidates who get allotment shall remit the fee as shown in the allotment memo at the colleges and join the course.
<b>08.10.2018 5.30 pm</b>	Heads of Institutions to submit non-join report through Online Admission Management System (OAMS) to the office of CEE

Candidates allotted to the courses/ college should remit the fee mentioned in the allotment slip at the college allotted and take admission as per the schedule prescribed by the Commissioner for Entrance Examination. Candidates who do not remit the prescribed fees/take admission within the stipulated time will lose their allotment as well as the claims for further allotments, if any.
