**ORDER**

As per the Government Order read above, Government have approved the prospectus for admission to M.Sc. Nursing Course 2019-20. As per the letter read as 2nd paper above, Director of Medical Education has requested to modify the eligibility criteria for nursing programmes as per the gazetted regulation of KUHS and eligibility criteria of Indian Nursing Council.

2. In the circumstance, in continuation of the Government order read above, Government are pleased to modify the admission criteria of academic eligibility in Clause 7.2.1 (a) for admission to M.Sc. Nursing programme mentioned in the Government order read as follows:-

*"Candidate should have passed the Bachelor Degree in Nursing of Kerala, Calicut, Mahatma Gandhi, Cochin, Kannur University and KUHS or regular course of other Universities recognized by INC and KUHS. Only candidates who have passed regular B.Sc. Nursing Degree Program with minimum of 55% aggregate marks will be*

eligible for admission.

Or

*Candidates who have passed the Post Basic B Sc Nursing of Kerala, Calicut, Mahatma Gandhi or Kannur University and KUHS or regular course of other Universities recognized by INC and KUHS, after acquiring General Nursing and Midwifery Course with +2 Science subject. Only Candidates who have passed regular Post Basic BSc Nursing degree program with minimum of 55% aggregate marks will be eligible for admission.*

*(Distance/Correspondence Degree Course is not eligible for M.Sc. Nursing admission) "*


