## NOTIFICATION ADMISSION TO MBBS/BDS COURSES - 2014

ALLOTMENT TO NEWLY INCLUDED PRIVATE SELF FINANCING MEDICAL/DENTAL COLLEGES PUBLISHED

The Government have accorded sanction to make allotment to the newly included Private Self Financing Medical/Dental colleges viz; Sree Gokulam Medical College & Research Foundation, Venjaramoodu, Thiruvananthapuram, Malabar Medical College & Research Centre, Modakkallur, Kozhikkode and Kannur Dental College Anjarakkandi, Kannur. Accordingly, the online allotment to the above Medical/Dental colleges and the allotment to the vacant seats in Government Dental colleges in the State is published herewith on the website www.cee.kerala.gov.in

The details of allotment of a candidate will be available on the home page of the candidate. The candidates should take a printout of the allotment memo and produce it before the authorities concerned at the time of admission/ fee payment.

The candidates who get an allotment to the newly included Private Self Financing Medical Colleges(Sree Gokulam Medical College & Research Foundation, Venjaramoodu, Thiruvananthapuram, Malabar Medical College & Research Centre, Modakkallur, Kozhikkode) should take the printout of the Allotment Memo and should take admission in the colleges concerned **on or before 30.09.2014**. The fees as shown in the Allotment Memo should be paid in the respective colleges at the time of admission.

Those candidates who receive an allotment to the Private Self Financing Dental College (Kannur Dental College Anjarakkandi, Kannur) should remit the fees/ balance fee (if applicable) to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the designated branches of **State Bank of Travancore** (SBT) and should take admission in the college **before 5 pm on 29.09.2014**. They can join the college on 30.09.2014 also, if the college authorities permit them to do so.

The candidates who get an allotment to BDS course in Govt. Dental Colleges should pay the fee/balance fee (if applicable) to be paid to the Commissioner for Entrance Examinations at any of the designated branches of **State Bank of Travancore** and they should join the colleges **on or before 30.09.2014**.

Those candidates who do not remit the fee/balance fee within the stipulated time and those who do not join the respective colleges will lose their allotment.

All the Medical/Dental College Authorities should submit the Non-Join Report to the Commissioner for Entrance Examinations before 5.30 pm on 30.09.2014.

Important:- This will be the last allotment to Medical/Dental Colleges. Hence the candidates who get allotments to such colleges should invariably join the allotted colleges. Otherwise they are liable to pay the Liquidated damages of Rs.10 lakhs as envisaged under Clause 12.2.4 of the Prospectus for KEAM-2014.

<u>Note:</u> In the event of allotment to Medical/Dental courses, the candidates admitted in Govt/ Govt. Controlled Self Financing University controlled/Private Self Financing Engineering Colleges and Private Self Financing Architecture Colleges are liable to pay the liquidated damages as per clause 12.2.4 of the Prospectus-2014 and orders issued by the Government.
