ORDER

The Commissioner for Entrance Examinations, vide letter read as above reported that the allotment to various Professional Degree Courses under KEAM.13 have been completed in the final phase of the Centralized Allotment Process conducted from 18/10/13 to 22/10/13 and after the said allotment certain seats are still vacant in some of the colleges under the following Universities

- a) Agricultural University, Vellanikkara, KAU, P.O, Thrissur
- b) Veterinary & Animal Sciences University, Pookot, Lakkadi.P.O
- c) Kerala University of Fisheries & Ocean Studies, Panangad P.O , Kochi

Therefore, the Commissioner for Entrance Examinations suggested that the Registrars of the said Universities may be permitted to fill up those seats which are vacant after the said phase of allotment, by conducting Spot Allotment/Admission.

Government, having examined the matter in detail, are pleased to order that seats that are vacant in the Colleges/Institutes under the Universities mentioned above after the completion of the final phase of Centralized Allotment Process conducted from 18/10/13 to 22/10/13, shall be filled through Spot Allotment/Admission as per the Clause 11.6.9 of the Prospectus issued vide G.O read above, by the Registrars of the Universities concerned. The seats shall be filled up from among the students eligible on the basis of merit from the rank list published by the Commissioner for Entrance Examinations. The Candidates who have obtained admission in Government merit seats for a course shall not be eligible to appear for the spot admission for that particular course. The admission shall be made strictly on the basis of merit. The criteria enshrined in the prospectus with regard to the reservation shall be strictly adhered to and in the absence of the such candidates under reservation category the seats shall be converted to State Merit Category. The admission process shall be completed by 5 pm on 31/10/13. The list of the students thus shall be

forwarded to the Commissioner for Entrance Examinations immediately after the completion of the allotment/admission process.
