## **NOTIFICATION**

## SECOND PHASE OF ALLOTMENT TO POST GRADUATE MEDICAL DEGREE/DIPLOMA COURSES. KERALA - 2018

## FACILITY FOR ONLINE OPTION REGISTRATION/DELETION/REARRANGEMENT AVAILABLE

As per the orders of the Hon'ble Supreme Court of India dated 03.05.2018 on WP(C) No. 357 of 2018, the States and Deemed/Central Institutions who have completed the second round of counseling without waiting for the reversion of the unfilled seats under All India Quota have been directed to conduct the second round of counseling again after reversion of the unfilled All India Quota seats. In the circumstance, the second round of counseling to the State Quota seats published on 26.04.2018 stands cancelled and the revised second round of counseling is scheduled to be conducted on 09.05.2018. The activities related to the second phase of Single Window System of allotment to Post Graduate Medical Degree/Diploma Courses for the year 2018 will commence on 05/05/2018. The vacant seats reverted from All India Quota, vacant/enhanced seats after the first round of counseling in Government Medical Colleges and the seats in Self-financing Medical Colleges including NRI and Minority Community quota seats shall be filled in this phase of allotment.

As per the letter no. V.11012/05/2017-MEP dated 27<sup>th</sup> April 2018 of Ministry of Health & Family Welfare, Government of India, the minimum qualifying percentiles of NEET-PG 2018 have been lowered by the National Board of Examinations. Accordingly, fresh applications were invited by the Commissioner for Entrance Examinations from the newly qualified candidates from 28.04.2018 to 03.05.2018. A revised rank list shall be prepared and published by the Commissioner for Entrance Examinations on 05.05.2018, by including the newly qualified candidates also. The allotment to be published on 09.05.2018 shall be based on the revised rank list thus prepared. But the allotment of those candidates who have already taken admission during the first phase of allotment will be protected.

Candidates newly included in the revised rank list to be published as well as those who have not registered any options yet can register options to all the course/college combinations. All the candidates in the revised rank list can register fresh options to the newly included courses/colleges as well as to those courses/colleges not opted in the first phase. The candidates who have already received an allotment in the 1<sup>st</sup> phase and joined in the course/college allotted can rearrange/delete their existing higher options and also register fresh options. Candidates who have not received any allotment in the first phase can also re-arrange/delete their existing options and also register fresh options. The facility for online option registration/deletion/re-arrangement shall be available in the website www.cee.kerala.gov.in from 05/05/2018 to 08/05/2018, 3 pm. Those who are holding All India Quota seats are not eligible to participate in this phase of allotment.

## Online Option confirmation is mandatory

The candidates who have received an allotment in the first phase and joined in the course/college allotted and also the candidates who have not received any allotment in the first phase who want to be considered for the second phase of allotment shall have to confirm their options online by clicking the 'Confirm' Button available in the Home page of the candidate. Those who do not confirm their options online will not be considered for the second phase of allotment for the existing options.

12/05/2018, 5pm	College authorities to approve and submit the list of admitted candidates through Online Admission Management System (OAMS)			

Candidates allotted to courses, and who remit the fee/balance fee as prescribed, should take admission in the college/course allotted as per the schedule prescribed by the CEE. No extension of time for reporting to the college will be granted under any circumstances. The candidates are liable to pay admission fee as prescribed by the University concerned at the time of admission.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies/Affiliation from the Universities.

Note: Candidates who are allotted and admitted as per the allotment published on 26.04.2018 need not obtain Transfer Certificate for the time being. Such candidates have to wait for the allotment to be published on 09.05.2018 and if they retain the allotment, they need only confirm their present admission. If such candidates get a different allotment, then they will have to obtain Transfer Certificate from the presently admitted course/college and join the course/college allotted as per this phase of allotment.
