SECOND PHASE OF ADMISSION TO P G MEDICAL (DEGREE / DIPLOMA) COURSES, KERALA-2016

The activities related to the second phase of centralized allotment to Post Graduate Medical Degree/Diploma Courses for the year 2016 will commence from 13.05.2016 (Friday).

Candidates who have already submitted online options and who want to participate in this phase of allotment must compulsorily confirm their online options by clicking the 'confirm' button available on his/her home page. After option confirmation such candidates can delete the unwanted higher options and can re-arrange their existing higher options. In addition all the eligible candidates can register fresh options to the newly included Private Self Financing Medical colleges. The facility for online option confirmation /deletion/re-arrangement/registration of fresh options will be available on the Website www.cee.kerala.gov.in from 13.05.2016 to 17.05.2016, 3 pm. Those who do not confirm their options online within the stipulated time will not be considered for allotment in this phase.

The seat matrices of Private Self Financing Medical Colleges and the fee structure approved by the Government are also available on the Website www.cee.kerala.gov.in.

The schedule for the second phase of allotment is given below:

| 21.05.2016 to 27.05.2016, 5 pm | All candidates should join the course and college to which they are allotted along with the required documents and Fee Receipt. |
| 27.05.2016 | Principals of Colleges to submit non-joining report through Online Admission Management System (OAMS) to the office of CEE |

Candidates allotted to the courses, and who remit the fee/balance fee as prescribed, should take admission in the college/course allotted as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not remit the prescribed fees/take admission will lose their allotment as well as the claims for further allotments, if any.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies / Affiliation from the Universities.

<u>Important:</u> The candidates who get an allotment to Government Medical Colleges/ Private Self Financing Medical Colleges or RCC should join the allotted colleges on or before 5 pm on 27th May, 2016. The candidates who are allotted with a subject in the counseling and who discontinues the course on any reason after this counseling shall be liable to pay the liquidated damages as per Clause 13-2 of the prospectus.
