ADMISSION TO THREE YEAR LL.B COURSE 2018 SPOT ALLOTMENT FOR FILLING UP OF VACANT SEATS

The second allotment for admission to the Three Year LL.B course in the Government and Self Financing Law colleges in the State was published on 06.10.2018 and the candidates were directed to join the allotted colleges before 4 pm on 10.10.2018. The vacant seats remaining after 10.10.2018, 4 pm shall be filled up through a Spot Allotment to be conducted by the Commissioner for Entrance Examinations at <u>T.J.M Hall in the LMS compound</u>, <u>Palayam</u>, <u>Thiruvananthapuram on 24th of October 2018</u>. The list of vacant seats in the various Law colleges will be published in the website www.cee.kerala.gov.in on 20.10.2018.

Candidates who have figured in the rank list of Three year LL.B course 2018 published by the Commissioner for Entrance Examinations and satisfying the eligibility criteria as per clause 6 in the prospects can participate in the Spot Allotment.

Online registration for Spot Allotment:

Candidates who wish to participate in the Spot Allotment shall have to download the 'Spot Allotment Registration Slip' by clicking the link 'Spot Allotment Registration' available in their home page from 20.10.2018 to 23.10.2018, 5 pm. Candidates can enter their Application Number & Password in the link 'Three Year LL.B 2018 - Candidate Portal' provided in the website www.cee.kerala.gov.in to log on to their home page. Candidates should be present in the venue of Spot allotment at 10 am on 24.10.2018 with this 'Spot Allotment Registration Slip'.

Guidelines for Spot Allotment

- (i) In the Spot allotment, transfer will not be permitted to students already admitted in a Government Law College to another Government Law College or to students already admitted in a Self Financing Law College to another Self Financing Law College.
- (ii) But in the Spot allotment, transfer will be permitted to students admitted in Self Financing Law colleges to Government Law colleges and vice-versa.

Candidates who get allotment in the Spot allotment shall have to join the allotted colleges before 27.10.2018, 5 pm along with the original documents mentioned in clause 18 of the Prospectus for admission to Three Year LL.B course-2018. The annual tuition fee, deposit (if applicable) and other fees as per the Government order published in the website of the Commissioner for Entrance Examinations should be remitted in the allotted colleges at the time of admission.

Note: The vacancies remaining, if any, in three year LL.B course in Government/Self Financing Law colleges after 5 pm on 27.10.2018 shall be filled up through Spot Admissions to be conducted by the college Principals concerned before 31.10.2018, 5 pm.
