ALLOTMENT TO PG HOMOEOPATHY COURSES -2020 **CANDIDATES CAN REGISTER NEW OPTIONS FOR THE THIRD PHASE OF** **THE CENTRALIZED ALLOTMENT PROCESS WHICH WILL BE TREATED AS THE MOP-UP PHASE ALSO**

The activities related to the third phase of the centralized allotment process (CAP) for admission to PG Homoeo Courses in the Government Homoeo colleges for the year 2020-21 will commence on 15.02.2021. This phase of the CAP will be treated as the Mop-up phase also. This is in line with the revised All India Quota (AIQ) counseling schedule wherein the unused AIQ seats are reverted to the respective state quota only after the third (mop-up) round of the All India Counseling which is an important event after which at least one full fledged regular phase of the state level CAP should take place for the students to explore the possibility of upgrading their allotments to the newly added seats without any restriction on the permissible course and college changes. So, those conditions of the Mop-up allotment (see clause 8.1.19 of the prospectus) which constrains the types of permissible course and college changes are not applicable in this phase insofar as it is a regular phase of the CAP also.

All Candidates who have figured in the rank list published by the Commissioner for Entrance Examinations and satisfy the eligibility criteria as per clause 4 in the PG Homoeo Prospectus can participate in this (Mop-Up) phase of the CAP. However, those candidates who are blocked from further participation in state quota allotments on account of being admitted in an AIQ seat or allotted a seat in the third (Mop-up) round of the All India Counseling will not be considered in this and subsequent phases of the state CAP.

As the current phase is the Mop-up phase also, candidates are advised to choose and order their options cautiously respecting the following conditions:

- i. The options registered by the candidates for this phase could be the basis for the subsequent stray vacancy filling allotments, if any. In that case, there will not be separate option registration or confirmation step prior to those allotments and the candidates will not be considered for stray vacancy filling allotment to those courses and colleges not chosen by them for the Mop-up phase allotment. So, failure to register options in this phase will make the candidate ineligible to get an allotment not only in this phase but in subsequent stray vacancy filling allotments also.
- ii. Any candidate who is allotted a seat in this (Mop-up) phase of the CAP or any subsequent stray vacancy filling allotments, irrespective of whether he/she joins or not joins the allotted seat, will not be further considered in the subsequent allotments.
- iii. Those candidates who have already been admitted in PG Homoeo Course, and if they get an allotment in this (Mop-Up) phase of the CAP will lose the existing admission.

- iv. If any candidate already holding a seat allotted in a previous phase, wants to quit that seat, the candidate must get TC from the college concerned before the last date of Option Registration for this (mop-up) phase and get it reported by the college to the CEE on the same day. Candidates will not be allowed to leave the seat allotted to them at any phase, once the option registration of this (mop-up) phase ends, except the ones caused by an up gradation to a higher option during the allotment process of this (mop-up) phase.
- v. Option registration is a mandatory step of this phase irrespective of whether options were registered or not registered in the previous phases. The options have to be registered through the Online Option Registration facility accessible after logging on to the PG Homoeopathy candidate portal on the website, www.cee.kerala.gov.in.

Candidates can register options to any of the courses existing in any of the colleges which the candidate wish to join irrespective of the existing vacancy position as the seats being vacated as part of the allotment process when candidates already holding a seat allotted to them in a previous phase are re-allotted to a higher option, will also be filled as part of the same allotment process itself. This is especially important in this phase as the options registered in this phase could be the basis for subsequent stray vacancy filling allotments also. Those candidates who have not registered their options within the stipulated time will not be considered for the allotments in this phase and subsequent stray vacancy filling allotments.

Candidates who wish to register options shall have to log on to their home Page provided in the website www.cee.kerala.gov.in by giving their Application Number & Password through the link "PG Ayurveda (Degree/Diploma) 2020 - Candidate Portal". Then by clicking the Menu item 'Option Registration', candidates can register their options.

Candidates who receive allotment should have attained the eligibility for admission as per Clause 4 of the Prospectus at the time of admission.
