NOTIFICATION
ALLOTMENT / ADMISSION TO POST GRADUATE DEGREE COURSES
IN HOMOEOPATHY (MD HOMOEEO), KERALA 2020-21

1. Applications are invited from the candidates who have qualified AIAPGET-2020 for admission to MD Homoeopathy Courses for the year 2020- 21 in the Government Homoeopathic Medical Colleges at Thiruvananthapuram and Kozhikode.
2. **Eligibility for Admission:**
 - (I) **Nativity: Applicant should be an Indian Citizen of Kerala origin**
 - (II) Applicant should have qualified AIAPGET-2020 and should have qualified as per clause 5.1 of the prospectus.
 - III) **Academic Eligibility:** Candidates who have passed the BHMS Degree (Direct/Graded) or its equivalent, declared there to, by the Central Council of Homoeopathy. Candidates who have completed one year of internship before the date of Counselling for allotment alone are eligible for admission(For more details See Clause 4.a).
 - IV) **Age:** The candidates otherwise eligible for admission should not be more than 45 years as on 01.01.2020, subject to relaxation to a maximum of five years in the case of SC/ST and to Teachers of Homoeopathic Medical Colleges.
3. **Qualifying Criteria:** All candidates including Service quota candidates seeking admission to MD Homoeopathy-2020 in the state of Kerala must qualify the AIAPGET- 2020 conducted by AIIA, New Delhi and should figure in the rank list prepared by the Commissioner for Entrance Examinations, Kerala.
4. **Mode of Selection:** The Selection of the candidates (including Service quota) shall be made from the rank list prepared by the Commissioner for Entrance Examinations, Kerala on the basis of the Qualifying marks in All India level common Entrance test namely AYUSH National Post Graduate Entrance Test (AIAPGET-2020). The minimum eligibility mark in the entrance test shall be 50th percentile in the case of general category and that of SC/ST/SEBC category shall be 40th percentile. In respect of candidates in persons with disability category, the minimum mark shall be at 45th percentile for general category and 40th percentile for SC/ST/SEBC category.
5. **Submission of Applications and Application Fee:** All candidates including Service Candidates seeking admission to the Post Graduate Degree Courses in Homoeopathy (MD Homoeo) can apply in the Online from **30.12.2020** provided in the website www.cee.kerala.gov.in of the Commissioner for Entrance Examinations and then remit the required fee by way of online payment or by way of e-challan available during the submission of online application. Payment through e-challan can be made in cash at, Head post offices/sub post offices in Kerala. After remitting the required application fee upload photo, signature of the candidates and all necessary certificates /Documents.

Service quota candidates including Rural Service should send their Application by taking printout of the online application along with NOC (No Objection Certificate) and all necessary Certificates to the Principal and Controlling Officer, Government Homoeopathic Medical College, Iranimuttom, Thiruvananthapuram, Pin 695009 before 03.01.2021 Rural Service Candidate should attach Service Certificate from the Director of Homoeopathy along with the printout of the application.

Application Fee for General Candidates including Service Candidates is Rs.900/- (Rupees Nine hundred only) In case of SC/ST candidates and those eligible for SC/ST benefits as per G.O.(Ms)No.25/05/SC/ST DD dated 22.03.2005 is **Rs.450/- (Rupees four hundred and fifty only)**. Application fee once remitted will not be refunded.

6. **Last date and time for online submission of application:** All candidates seeking admission to the course should submit the online application along with uploaded Certificates/Documents mentioned in clause 6.3.6 of the prospectus before 3 pm of 03.01.2021
7. Candidates will be allowed, neither to include any information in the application form nor to submit any certificates/Documents claiming reservation or any benefits, after the online submission of the application.
8. Candidates may go through the various provisions of the Prospectus for admission to PG Homoeo courses 2020 available in the Official website of the Commissioner for Entrance Examinations www.cee.kerala.gov.in before filling up the Online application forms.
