FIFTH PHASE OF ALLOTMENT TO MEDICAL (EXCEPT MBBS/BDS) & ALLIED COURSES

## ONLINE OPTION CONFIRMATION IS MANDATORY

The activities related to the fifth and final phase of allotment to Medical & Allied Courses except MBBS/BDS Courses in Kerala -2015 begins on 14.10.2015. The Candidates who want their higher order options to be considered for this phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After Online Option Confirmation, the candidates can re-arrange /delete their higher order options and also register fresh options to newly added Courses/Colleges from 14.10.2015 to 15.10.2015, 5 pm, through the website www.cee.kerala.gov.in . On the basis of options received upto 5 pm on 15.10.2015, the fourth phase allotment to Medical & Allied Courses will be published in the evening on 16.10.2015. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on any date from 17.10.2015 to 20.10.2015. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, the candidates should join the course/college allotted as per the fifth phase before 5 pm on 20.10.2015. This will be the last phase of allotment to Medical & Allied Courses. Hence the candidates who get allotments to such colleges should invariably join the allotted colleges. Otherwise they are liable to pay the Liquidated damages as envisaged under Clause 12.2.4 of the Prospectus for KEAM-2015.

The detailed schedule for the 5<sup>th</sup> and final phase of allotment is furnished below.

<u>Those who do not confirm their options online will not be considered for the fifth phase</u> <u>allotment to Medical (Except MBBS/BDS) & Allied courses.</u> However his/her existing allotment shall be retained.

Important: The Allotment to Mannam Ayurveda Co-operative Medical College, Pandalam, Ahalia Ayurveda Medical College, Palakkad, Pankaja Kasthuri Ayurveda College, Kattakkada, Thiruvananthapuram, Parassinikadavu Ayurveda Medical College, Parassinikkadavu, Kannur and Santhigiri Ayurveda Medical College, Palakkad will be subject to the result of the writ petitions pending before the Hon'ble High Court of Kerala.

<u>Note:</u> Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to Medical & Allied Course only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to Medical & Allied Course subject to the conditions in GO(Ms) No. 252/2014/H.Edn. Dated: 07.06.2014.

The Candidates admitted in other Private Self Financing Engineering/Architecture Colleges who are allotted to Medical & Allied courses through KEAM 2015 need not pay the Liquidated Damages as per GO(Ms) No.372/2015/H.Edn. Dated: 03.07.2015 and GO(Ms) No.378/2015/H.Edn. Dated: 03.07.2015 for getting Transfer Certificate and other Documents. But the fees remitted for the year shall not be refunded.
