FOURTH PHASE ALLOTMENT TO MEDICAL & ALLIED COURSES EXCEPT MBBS/BDS COURSES PUBLISHED

The fourth phase allotment to Medical & Allied Courses except MBBS/BDS Courses in Kerala -2015 is published herewith on the website <u>www.cee.kerala.gov.in</u>. Those students who had confirmed their options online within the stipulated time alone are considered for the fourth phase allotment to Medical & Allied Courses.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate. The candidates should take a printout of the allotment memo pertaining to the fourth phase allotment to Medical & Allied courses and produce it before the authorities of **State Bank of Travancore (SBT)** for payment of fee/balance fee. The list of designated branches of **SBT** is available on the website.

Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the designated branches of State Bank of Travancore on any date from 08.10.2015 to 13.10.2015 and should join the course/college allotted before 5 pm on 13.10.2015.

The candidates who get a change in allotment than that of the previous allotment should pay the balance fee, if applicable, in a designated branch of SBT on any date from 08.10.2015 to 13.10.2015 and should join the course/college allotted as per the allotment memo before 5 pm on 13.10.2015.

Those candidates who do not remit the fee/balance fee within the stipulated time and who do not join the course/college allotted within the stipulated time will lose their allotment and also their existing higher options under Medical & Allied courses.

<u>Note:</u> Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to Medical & Allied Course only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to Medical & Allied Course subject to the conditions in GO(Ms) No. 252/2014/H.Edn. Dated: 07.06.2014.

The Candidates admitted in other Private Self Financing Engineering/Architecture Colleges who are allotted to Medical & Allied courses through KEAM 2015 need not pay the Liquidated Damages as per GO(Ms) No.372/2015/H.Edn. Dated: 03.07.2015 and GO(Ms) No.378/2015/H.Edn. Dated: 03.07.2015 for getting Transfer Certificate and other Documents. But the fees remitted for the year shall not be refunded.
