## NOTIFICATION <u>KEAM 2015</u> <u>FOURTH PHASE OF ALLOTMENT TO MEDICAL & ALLIED COURSES</u> <u>EXCEPT MBBS/BDS COURSES</u> <u>ONLINE OPTION CONFIRMATION IS MANDATORY</u>

The activities related to the fourth phase allotment to Medical & Allied Courses except MBBS/BDS Courses in Kerala -2015 begins on **03.10.2015**. The Candidates who want their higher order options to be considered for this phase of allotment shall have to log into their Home Page and confirm their options by clicking the 'Confirm' button available therein. After Online Option Confirmation, the candidates can re-arrange /delete their higher order options and also register fresh options to newly added Courses/Colleges from the evening of **03.10.2015** to **06.10.2015**, **3** pm, through the website <u>www.cee.kerala.gov.in</u>. On the basis of options received upto **3** pm on **06.10.2015**, the fourth phase allotment to Medical & Allied Courses will be published in the evening on **07.10.2015**. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on any date from **08.10.2015** to **13.10.2015**. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, the candidates should join the course/college allotted as per the fourth phase before **5** pm on **13.10.2015**.

Candidates allotted under SC/ST/OEC Community category and those having benefit as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005, have to remit Rs. 100/- as token of having accepted the allotment:

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

<u>Note:</u> Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to Medical & Allied Course only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to Medical & Allied Course subject to the conditions in GO(Ms) No. 252/2014/H.Edn. Dated: 07.06.2014.

The Candidates admitted in other Private Self Financing Engineering/Architecture Colleges who are allotted to Medical & Allied courses through KEAM 2015 need not pay the Liquidated Damages as per GO(Ms) No.372/2015/H.Edn. Dated: 03.07.2015 and GO(Ms) No.378/2015/H.Edn. Dated: 03.07.2015 for getting Transfer Certificate and other Documents. But the fees remitted for the year shall not be refunded.
