## ALLOTMENT TO FILL UP THE VACANT SEATS IN MBBS/BDS COURSES PUBLISHED

The online allotment to fill up the 3 vacant MBBS seats in Government Medical Colleges, 3 vacant MBBS seats in the two Private Self Financing Medical Colleges (DM Wayanad Institute of Medical Sciences, Wayanad and Mount Zion Medical College, Pathanamthitta) and 5 vacant BDS seats in Government Dental Colleges in Kerala is published herewith on the website <a href="https://www.cee.kerala.gov.in">www.cee.kerala.gov.in</a>. As per the orders of Hon'ble High Court of Kerala on WP(C) No. 27728/2015, one seat in Government Medical College, Thiruvananthapuram has been kept vacant.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate. The candidates should take a printout of the allotment memo pertaining to the vacancy filling phase for MBBS/BDS courses and produce it before the authorities of **State Bank of Travancore (SBT)** for payment of fee/balance fee. The list of designated branches of **SBT** is available on the website.

Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the allotment memo at any of the designated branches of State Bank of Travancore on 22.09.2015 or 23.09.2015 and should join the course/college allotted before 5 pm on 23.09.2015.

The candidates who get a change in allotment than that of the previous allotment should pay the balance fee, if applicable, in a designated branch of SBT on 22.09.2015 or 23.09.2015 and should join the course/college allotted as per the allotment memo before 5 pm on 23.09.2015.

Those candidates who do not remit the fee/balance fee within the stipulated time and who do not join the course/college allotted within the stipulated time will lose their allotment and also their existing higher options under MBBS/BDS courses.

The Allotment and Admission in DM Wayanad Institute of Medical Sciences, Meppadi P O, Wayanad, P K Das Institute of Medical Sciences, Vaniyamkulam, Ottapalam, Palakkad and Mount Zion Medical College, Chayalode, Adoor, Pathanamthitta shall be subject to the result of the Special Leave Petitions pending before the Hon'ble Supreme Court of India and the final judgment of the Hon'ble High Court of Kerala on the Writ Appeals pending before it.

Important:- This is the last phase of allotment to the three Private Self Financing Medical Colleges (DM Wayanad Institute of Medical Sciences, Wayanad, P K Das Institute of Medical Sciences, Palakkad and Mount Zion Medical College, Pathanamthitta). Hence the candidates who get allotments to the above colleges should invariably join the colleges. Otherwise they are liable to pay the Liquidated damages of Rs.10 lakhs as envisaged under Clause 12.2.4 of the Prospectus for KEAM-2015.

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

<u>Note:</u> Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to MBBS/BDS Courses only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to MBBS/BDS Courses subject to the conditions in GO(Ms) No. 252/2014/H.Edn. Dated: 07.06.2014.

The Candidates admitted in other Private Self Financing Engineering/Architecture Colleges who are allotted to Medical & Allied courses through KEAM 2015 need not pay the Liquidated Damages as per GO(Ms) No. 372/2015/H.Edn. Dated: 03.07.2015 and GO(Ms) No.378/2015/H.Edn. Dated: 03.07.2015 for getting Transfer Certificate and other Documents. But the fees remitted for the year shall not be refunded.
