THIRD PHASE OF ALLOTMENT TO MEDICAL & ALLIED COURSES - 2015
ONLINE OPTION CONFIRMATION IS MANDATORY

The activities related to the Third phase of Allotment to Medical & Allied courses for the year 2015 will begin from **05.09.2015 (Saturday)**.

The Candidates who want their higher order options to be considered for the third phase of allotment shall have to login to their Home Page and confirm their options by clicking the 'Confirm' button available therein. After **Online Option Confirmation**, the candidates can re-arrange /delete their higher order options and also register fresh options to newly added Courses/Colleges from **05.09.2015 to 08.09.2015, 3 pm**, through the website www.cee.kerala.gov.in. On the basis of options received up to 3 pm on **08.09.2015**, the third phase allotment to Medical & Allied Courses will be published on **09.09.2015**. Candidates who receive allotment shall have to take a printout of their allotment memo and remit the fee/ balance fee payable to the CEE, in one of the designated branches of the State Bank of Travancore (SBT) on any working day from **10.09.2015 to 15.09.2015**. The list of designated branches of SBT is available on the website. After remitting the fee/balance fee in any of the designated branches of SBT, the candidates should join the course/college allotted as per the third phase before 5 pm on **15.09.2015**. **Those who do not confirm their options online will not be considered for the third phase allotment and also their higher options in Medical & Allied courses will not be available in the subsequent phases.** However his/her existing allotment shall be retained.

The "Option Facilitation Centres" [OFC] and "Help Desks" [HD], having internet facility, will be functioning throughout the State during this period for providing necessary help to the candidates for registration of options. SCHEDULE FOR THE THIRD PHASE OF ALLOTMENT TO MEDICAL & ALLIED COURSES:

05.09.2015	Website opens for Online Option Confirmation and for enabling re-arrangement / deletion of higher options and registration of fresh options to newly added Courses/Colleges.
08.09.2015 (3 pm)	Time for Online Option Confirmation and re-arrangement/ deletion /addition of options ends
09.09.2015	Publication of Allotment
10.09.2015 to 15.09.2015	Candidates who have received allotment should remit the fee /balance fee payable in SBT and should report before the college authorities to join the allotted college/course.
15.09.2015, 5.30 pm	All the college authorities should approve and submit the list of admitted candidates.

The schedule for further allotments, if any, will be notified in due course.

The eligible candidates can register fresh options to the following Medical/Dental/ Ayurveda Colleges in this phase.

* This fee concession benefit will be available to the candidates only after completion of allotment process. Hence candidates should remit the full fee to the Commissioner for Entrance Examinations at the time of allotment. Balance fee will be refunded to the candidates.

Token Deposit :

Candidates allotted under SC/ST/OEC Community category and those having benefit as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005, have to remit token deposit at the rates mentioned below, as token of having accepted the allotment:

1. MBBS/BDS courses : Rs. 1000/-
2. Other Courses : Rs. 100/-

The candidates getting allotment are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Managements is not approved by the Hon'ble Court or any competent authority.

Note: Candidates admitted in Govt./ Govt. Controlled Self Financing Engineering Colleges can accept the new allotment to Medical/Medical Allied Courses only after paying the liquidated damages as per clause 12.2.4 of the Prospectus-2015 and orders issued by the Government.

Candidates admitted in Private Self Financing Engineering Colleges under Kerala Catholic Engineering College Managements Association can accept the new allotment to Medical & Allied Courses subject to the conditions in GO(Ms) No. 252/2014/H.Edn. Dated: 07.06.2014.


The issue of Transfer Certificate and other documents to the students admitted in other Private Self Financing Engineering/Architecture Colleges consequent to the allotment through KEAM 2015 shall be subject to the conditions in GO(Ms) No. 372/2015/H.Edn. Dated: 03.07.2015 and GO(Ms) No.378/2015/H.Edn. Dated: 03.07.2015

The allotment to Colleges/Courses will be subject to recognition of All India Regulatory Bodies/Affiliation from the Universities.
