CENTRALIZED ALLOTMENT TO PROFESSIONAL DEGREE COURSES, KERALA-2015 SECOND PHASE ALLOTMENT PUBLISHED

The Second phase allotment to Professional Degree Courses in Kerala -2015 is published herewith on the website www.cee.kerala.gov.in . Allotments to Engineering and Architecture courses only have been done in the second phase.

The details of allotment of a candidate such as Name, Roll Number, Allotted Course, Allotted College, Category of Allotment, Fee details etc. will be available on the home page of the candidate. The candidates should take a printout of the second phase allotment memo and produce it before the authorities of **State Bank of Travancore (SBT)** for payment of fee/balance fee. The list of designated branches of **SBT** is available on the website.

Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the second phase allotment memo at any of the designated branches of State Bank of Travancore on any date from 10.07.2015 to 15.07.2015 and should join the course/college allotted before 5 pm on 15.07.2015.

The candidates who get a change in allotment than that of the first allotment should pay the balance fee, if applicable, in a designated branch of SBT on any date from 10.07.2015 to 15.07.2015 and should join the course/college allotted as per the second phase allotment memo before 5 pm on 15.07.2015.

The candidates who are allotted to Medical & Allied courses as per the first phase allotment and who have no change in allotment in the second phase need not join the course/college allotted.

Thus all the candidates who have an allotment under Engineering/Architecture courses should join the course/college allotted as per the second phase allotment memo before 5 pm on 15.07.2015. The detailed schedule showing the date and time for joining the Engineering/Architecture courses is published in the website www.cee-kerala.org. The candidates who are not able to join the course/college as per the schedule can join the college on or before 15.07.2015 by intimating the college authorities concerned.

Those candidates who do not remit the fee/balance fee within the stipulated time and who do not join the course/college allotted within the stipulated time will lose their allotment and also their existing higher options under Engineering/Architecture courses. They will not be considered for further online allotments under Engineering/Architecture streams.

The third phase of Allotment to Engineering/Architecture courses will be published in the third week of July, 2015. The third round will be the last round of allotment to Govt/Govt. Controlled Self Financing/Private Self Financing Engineering/Architecture Colleges. Facility for rearranging/deleting the existing options and for online option confirmation will be provided before the third round of allotment.
