NOTIFICATION

ALLOTMENT TO MBBS/BDS COURSES - 2014

FRESH OPTIONS INVITED FOR NEWLY INCLUDED PRIVATE SELF FINANCING DENTAL COLLEGE AND PRIVATE SELF FINANCING MDICAL COLLEGES LIKELY TO BE INCLUDED

(GO (Rt) No. 3094/2014/H&FWD dated: 19.09.2014)

As per the Government Order cited above, 50% of the total seats in BDS courses in Kannur Dental College Anjarakkandi, Kannur will be filled up by the Commissioner for Entrance Examinations.

The Hon'ble Supreme Court of India in its Order dated: 18.09.2014 on WP (C) No. 469 of 2014 and connected cases has ordered to certain Private Self Financing Medical Colleges (Sree Gokulam Medical College & Research Foundation, Venjaramoodu, Thiruvananthapuram, Kannur Medical College, Anjarakkandi, Kannur and Malabar Medical College & Research Centre, Modakkallur, Kozhikkode) to file an undertaking with in 10 days from the date of Order to the effect that there is no defect in the Medical Colleges run by them and that their deposit with the MCI which is around Rs. 10 crores, be forfeited by way of penalty if the statement made in the undertaking is found to be incorrect at the time of the next inspection. It is also mentioned in the said order that if undertakings as stated above are filed by the Institutions managing Medical Colleges for the academic year 2014-15, admissions shall be given to the students by the State Authority from the merit list prepared by the States and they shall be charged fees prescribed by the Government Medical Colleges in the State.

In these circumstances fresh options are invited from candidates included in the rank list for MBBS/BDS courses - 2014 except those who have been allotted to Govt/Govt. Controlled Self Financing/Private Self Financing Medical Colleges and Govt. Controlled Self Financing/Private Self Financing Dental Colleges through the Website www.cee.kerala.gov.in from 25.09.2014 to 26.09.2014, 5 pm. Candidates who do not register their options within the stipulated time will not be considered for allotment to the above colleges under any circumstances. The vacancies, if any, created in Government Dental Colleges will be filled up in this allotment. Hence the candidates who desire to be considered for this allotment including that in Government Dental Colleges should Confirm their options online with in the stipulated time. Those who do not confirm their options online within the stipulated time will not be considered for this allotment. The allotment will be published in due course. The "Option Facilitation Centres" [OFC] and "Help Desks" [HD], having internet facility, will be functioning throughout the State during this period for providing necessary help to the candidates for registration of options. ^{*} This fee concession benefit will be available to the candidates only after completion of allotment process. Hence candidates should remit the full fee to the Commissioner for Entrance Examinations at the time of allotment. Balance fee will be refunded to the candidates.

Token Deposit:

Candidates allotted under SC/ST/OEC Community category and those having benefit as per G.O. (MS) 25/2005/SCSTDD, dated: 20.06.2005, have to remit token deposit of Rs. 1000/- (Rupees One Thousand) as token of having accepted the allotment:

The candidates getting allotment in the Private Self Financing Dental College are liable to remit the fee fixed by the Fee Regulatory Committee if the fee fixed on the basis of agreement between Government and Self-financing Management is not approved by the Hon'ble Court or any competent authority.

Important:- This will be the last allotment to newly included Medical/Dental Colleges. Hence the candidates who get allotments to such colleges should invariably join the colleges allotted. Otherwise they are liable to pay the Liquidated damages of Rs.10 lakhs as envisaged under Clause 12.2.4 of the Prospectus for KEAM-2014.
