## CENTRALIZED ALLOTMENT TO PROFESSIONAL DEGREE COURSES, KERALA-2014 SECOND PHASE ALLOTMENT PUBLISHED

The Second phase allotment to Professional Degree Courses except MBBS/BDS Courses in Kerala -2014 is published herewith on the website www.cee.kerala.gov.in

The details of allotment of a candidate will be available on the home page of the candidate. The candidates should take a printout of the second phase allotment memo and produce it before the authorities of State Bank of Travancore (SBT) for payment of fee/balance fee. The list of designated branches of SBT is available on the website. Those candidates who receive an allotment afresh should remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the second phase allotment memo at any of the designated branches of State Bank of Travancore on 21.07.2014 or 22.07.2014 in order to accept the allotment.

The candidates who get a change in allotment than that of the first allotment should pay the balance fee, if applicable, in SBT. All the candidates who have an allotment other than MBBS/BDS courses should pay the fee/balance fee (as applicable) to be paid to the Commissioner for Entrance Examinations at any of the designated branches of State Bank of Travancore and they need not join the colleges after the second allotment. Those candidates who do not remit the fee/balance fee within the stipulated time will lose their allotment and also their higher options. They will be removed from the entire online allotment process for the existing courses/colleges.

The third phase of Allotment to the Professional Degree Courses except MBBS/BDS Courses will be published on 23.07.2014 after excluding the students who do not remit the fees/balance fees after the second round of allotment. No facility for rearranging/deleting the existing options or addition of fresh options will be provided after the second round of allotment. The third round will be the last round of allotment to Govt/Govt. Controlled Self Financing/Private Self Financing Engineering/Architecture Colleges. All the students who have an allotment after the third round should join the course/college concerned. Those who get an allotment in the Private Self Financing Engineering/Architecture colleges after the third phase should invariably join the colleges. Otherwise the liquidated damages envisaged as per Clause 12.2.4 of the Prospectus shall be imposed on such students.

<u>Note:</u> All the higher order options of the candidates who get allotment/admission in Private Self Financing Engineering/Architecture Colleges after the Third Phase of Allotment will be deleted.
