## <u>CENTRALIZED ALLOTMENT TO PROFESSIONAL DEGREE COURSES, KERALA-2014</u> <u>FIRST PHASE ALLOTMENT PUBLISHED</u>

The first phase allotment to Kerala Medical/Engineering/Architecture Courses-2014 is published herewith on the website <u>www.cee.kerala.gov.in</u>. The allotment is based on 18,49,064 options filed by a total of 53,687 candidates.

The details of allotment of a candidate will be available on the home page of the candidate. The candidates should take a printout of the first phase allotment memo and produce it before the authorities of **State Bank of Travancore (SBT)** for payment of fees. Those candidates who receive an allotment shall remit the fees to be paid to the Commissioner for Entrance Examinations as specified in the first phase allotment memo at any of the designated branches of **State Bank of Travancore** from **26.06.2014** to **03.07.2014** in order to accept the allotment. The list of designated branches of **SBT** is available on the website.

The candidates allotted to MBBS / BDS courses alone should report for admission in the respective colleges from 27.06.2014 to 03.07.2014 along with the first phase allotment memo, mark data sheet and originals of all documents specified in Clause 11.7.1 of the prospectus. The balance amount of fees, if any, should be paid at the college. In the case of MBBS/BDS courses, those candidates who do not remit the fees or do not join the respective Medical/Dental colleges within the stipulated time will lose their allotment and also their higher options. They will be removed from the entire online allotment process for the existing courses/colleges. All Medical/Dental Colleges included in the first phase of allotment should furnish the non-joining report to the Commissioner for Entrance Examinations at 5.30 pm on 03.07.2014.

The Candidates who are allotted to all other courses except MBBS/BDS courses need only pay the fees to be paid to the Commissioner for Entrance Examinations at any of the designated branches of **State Bank of Travancore** and they need not join the colleges after the first allotment. Those candidates who do not remit the fees within the stipulated time will lose their allotment and also their higher options. They will be removed from the entire online allotment process for the existing courses/colleges.

The activities relating to the second phase of allotment will be notified later.
