### **NOTIFICATION**

#### **SECOND PHASE OF ALLOTMENT TO P G MEDICAL (DEGREE / DIPLOMA) COURSES, KERALA-2017 FACILITY FOR ONLINE REGISTRATION/OPTION CONFIRMATION**

The activities related to the second phase of centralized allotment to Post Graduate Medical Degree/Diploma Courses for the year 2017 will commence from 12.05.2017 (Friday). Private Self Financing Medical Colleges and Deemed University have been included in this phase, for allotment.

Candidates who have already submitted online options and who want to participate in this phase of allotment must compulsorily confirm their existing options by clicking the 'Confirm' button available in his/her home page. After **online option confirmation**, such candidates can delete the unwanted higher options and can re-arrange their existing higher options. In addition, all the eligible candidates can register fresh options to the newly included Private Self Financing Medical colleges and Deemed University. The facility for online option confirmation /deletion/re-arrangement/filing of fresh options will be available on the Website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) from 12.05.2017 to 17.05.2017, 3 pm. Those who do not confirm their options online within the stipulated time will not be considered for allotment in this phase.

The candidates who are eligible to apply for Christian community quota in Self Financing Medical Colleges under Kerala Christian Professional College Management Federation should opt for the same and submit their options through '**P G Medical 2017 Candidate Portal**' in the website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in). Candidates applying under Christian Community Quota as above should obtain a certificate to that extent (in the downloaded proforma) from the authority concerned and upload it by clicking the Menu Item 'Upload' available in the home page. The candidates applying under NRI Quota in Self Financing Medical Colleges and Deemed University shall have to opt for the same and upload the documents in proof of NRI Quota claim through the website.

Those candidates, who get allotment in Self Financing Medical Colleges and Deemed University in the NRI and Community Quota seats, must produce the originals of the uploaded documents and other certificates for verification in the counseling to be held on 22.05.2017 at Thiruvananthapuram. It is mandatory that the candidates must present with all the relevant documents at the time of certificate verification. The venue and time of certificate verification will be informed in due course. The allotment to the NRI quota will be as per the GO(MS) No. 193/2013/H&FWD dated 22.05.2013 and orders of the Admission Supervisory & Fee Regulatory Committee. The candidates who are included in the NEET PG 2017 rank list and not included in the Kerala State Merit list prepared and published by the Commissioner for Entrance Examinations shall have the facility to register afresh and to submit their options online to the Deemed University and to the Management/NRI Quota seats in the newly included Self Financing Colleges so as to participate in the allotment process. Such candidates, if getting allotment shall have to produce their proof for Kerala Nativity and other documents in original for the scrutiny to be held on 22.05.2017 at Thiruvananthapuram. Candidates who register afresh and get allotment in Deemed University shall have to produce the proof for Nationality at the time of counseling.

**The schedule for the second phase of allotment is given below:**

12.05.2017	Website opens for enabling online option confirmation/re-arrangement/ deletion of existing options / filing fresh options to the newly included colleges and courses and for registration of new candidates.
17.05.2017 - 3 pm	Facility for online option confirmation/ registration /re-arrangement / deletion of options ends.
19.05.2017	<b>Publication of second phase of allotment</b>
22.05.2017	<b>Counseling for the verification of documents in respect of candidates allotted to Deemed University and Community/NRI quota seats in Self Financing colleges in the presence of the representative of the college.</b>
23.05.2017 to 25.05.2017, 5 pm	All candidates who get allotment shall remit the fee / balance fee as shown in the allotment memo to the colleges at the time of admission
25.05.2017, 5.30 pm	Heads of Institutions to submit non-join report through Online Admission Management System (OAMS) to the office of CEE

Candidates allotted to the courses, and who remit the fee/balance fee as prescribed, should take admission in the college/course allotted as per the schedule prescribed by the Commissioner for Entrance Examinations. Candidates who do not remit the prescribed fees/take admission within the stipulated time will lose their allotment as well as the claims for further allotments, if any.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies / Affiliation from the Universities.
