## THIRD PHASE OF CENTRALIZED ALLOTMENT TO PROFESSIONAL DEGREE COURSES 2011

The activities relating to the third Phase of Allotment to Professional Degree Courses 2011 will begin on 24.08.2011. Facility will be opened for candidates to re-arrange higher options, delete unwanted options and to register options to newly started Courses and Colleges from 24.08.2011 to 26.08.2011 on the official website www.cee.kerala.gov.in. The third phase of allotment will be published on 30.08.2011 based on the options registered till 5 pm on 26.08.2011. Candidates who receive allotment in this third phase will have to remit the fee/additional fee/deposit at the designated branches of SBT on 31.08.2011, 01.09.2011 or 02.09.2011. The list of SBT branches is given on the website www.cee-kerala.org. Those candidates who have remitted the fees can join the colleges from 31.08.2011 to 03.09.2011.

Those candidates who are satisfied with the allotment received in the Second allotment should cancel their higher options. The facility to cancel the options is available only through the home page of the candidate.

# Fee concession in Government Controlled Self-financing Medical Colleges: Academy of Medical Sciences, Pariyaram, Kannur (KNM) and Co-operative Medical College, Kochi (CMC))

BPL/Lower income/SEBC categories of students admitted to KNM and CMC can avail fees concession benefits as specified below :

- a) 7 candidates who are belonging to BPL/Lower income category allotted by the CEE to CMC can study at the fee rate of ₹ 25000 and 10 candidates belonging to the above category allotted to KNM can study at the fee rate of ₹ 23000. Rank/category will not be the criteria for selecting these candidates. SC/ST/OEC students who already enjoy fee benefit will not be considered for this concession.
- b) 13 candidates who belong to the SEBC category allotted to CMC can study for ₹ 37000 and 13 candidates who belong to the SEBC category allotted to KNM can study for ₹ 44000. These candidates will be selected on the basis of rank.

The fee benefits will be granted only after the closure of allotments to MBBS Course. Hence candidates allotted to CMC will have to remit the State Merit fee, ₹ 87000 and those allotted to KNM, ₹ 1,00,000 at the time of allotment. The CEE will refund the balance amount to the candidates who are eligible for fee benefits after the completion of allotment process.

The annual tuition fee fixed for the Government seats in the Private Self-financing Engineering colleges is ₹ 60,000. The office notification issued on 05.08.2011 by this office in connection with the fee concession benefits will be applicable to new Private Self-financing Engineering Colleges included in the third phase of allotment.

Candidates who received allotment in the third phase, but wish to cancel their allotment after remitting the required fee can do so by submitting the filled in proforma at the office of the Commissioner for Entrance Examinations before 5 pm on 13.09.2011. The proforma for Cancellation of allotment is provided on the website www.cee-kerala.org. No cancellation is permissible to students allotted to Private Self-financing Engineering Colleges after 13.09.2011.

The allotment to the 75 Private Self-financing Engineering Colleges included in the Second phase will come to an end with the next phase of allotment (4<sup>th</sup> Phase). Candidates allotted to Private Self-financing Engineering Colleges as per the 4<sup>th</sup> allotment should compulsorily take admissions to these Colleges. If they do not take admission, they are liable to be penalised as per clause 12.2.4(c) of Prospectus 2011.

The higher options of candidates who are allotted to the 75 Private Self-financing Engineering Colleges in the 4<sup>th</sup> phase of allotment will be cancelled. Nevertheless, this is not applicable to the new colleges included in the 3<sup>rd</sup> phase of allotment.

The notification regarding the fourth phase of allotment will be issued in due course.
