**SECOND PHASE OF ALLOTMENT TO POST GRADUATE MEDICAL  
DEGREE/DIPLOMA COURSES, KERALA - 2015**

The activities related to the second phase of Single Window System of allotment to Post Graduate Medical Degree/Diploma Courses for the year 2015 will commence from 29.04.2015 (Wednesday).

In this phase, the Commissioner for Entrance Examinations will make allotments to the General Quota seats only. The General Quota candidates who have already submitted online options and who want to participate in this phase of allotment must compulsorily confirm their online options by clicking the 'confirm' button available on his/her home page. After option confirmation such candidates can delete the unwanted higher options and can re-arrange their existing higher options. In addition all the eligible candidates included under General Quota can register fresh options to the newly included Government Controlled Self financing and Private Self Financing Medical colleges. The facility for online option confirmation /deletion/re-arrangement/registration of fresh options will be available on the Website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in) from 29.04.2015 to 02.05.2015, 3 pm. Those who do not confirm their options online within the stipulated time will not be considered for allotment in this phase.

The seat matrices of Government Controlled/Private Self Financing Medical Colleges and the fee structure approved by the Government are also available on the Website [www.cee.kerala.gov.in](http://www.cee.kerala.gov.in).

The allotment to Service Quota candidates will be made later on the basis of the Orders of Hon'ble High Court of Kerala in the writ petitions pending before the Court.

**The schedule for the second phase of allotment is given below:**

29.04.2015	Website opens for enabling online option confirmation/re-arrangement / deletion of existing options and for filing fresh options to newly included colleges and courses
02.05.2015 - 3 pm	Facility for option confirmation/ registration /re-arrangement / deletion of options ends.
03.05.2015	Publication of second phase of allotment
04.05.2015 to 08.05.2015	All candidates who get an allotment shall remit the fee / balance fee as shown in the allotment memo at selected branches of State Bank of Travancore (SBT).
04.05.2015 to 08.05.2015, 5 pm	All candidates should join the course and college to which they are allotted along with the required documents and Fee Receipt.
30.05.2015	Submission of Non-joining report by the College authorities before 5.30 pm.

Candidates allotted to any of the courses, and who remit the fee/balance fee as prescribed, should take admission in the college/course allotted as per the schedule prescribed by the CEE. Candidates who do not remit the prescribed fees/take admission will lose their allotment as well as the claims for further online allotments, if any.

The allotment to Colleges / Courses will be subject to recognition of All India Regulatory Bodies / Affiliation from the Universities.
