ORDER

In the Government order read as 1st paper above, Government have approved the Prospectus for admission to 3 year LLB Course for the year 2014-15 and as per G.O. read as 2nd paper above, the last date for admission to the course was extended upto 31.10.2014.

- 2. The Commissioner for Entrance Examinations in the letter read above, has informed that even after the final phase of allotment, merit seats will be remaining vacant in some colleges due to want of options from qualified candidates and non-joining of allotted candidates. He has, therefore, requested to issue orders authorizing the Principals of Govt. Law Colleges and Self Financing Law Colleges for conducting spot admission to fill up the vacancies.
- 3. Government have examined the matter and are pleased to accord sanction to the Principals of Government Law Colleges and Self financing Law Colleges for filling up the vacancies in Govt merit seats for 3 year LLB Course 2014-15 in their respective colleges after the final phase of allotment by conducting Spot Admission from the rank list and category list published by the Commissioner for Entrance Examinations on 24.10.2014. The Principals are also directed to conduct the spot admission after giving wide publicity through leading news papers and various mass media and by strictly observing merit and reservation principles, as laid down in the Prospectus for Admission to 3 Year LLB Course 2014-15. No admissions shall be made to the son hourse after 31.10.3.314 even if vacancies are the strengarts.

4. The validity of the rank list prepared by the Commissioner for Entrance Examinations for 3 year LLB Course 2014-15 is also extended upto 31.10.2014.
