FINAL PHASE OF ALLOTMENT TO MBBS/BDS COURSES 2009 : LIQUIDATED DAMAGES FOR SPOILING GOVERNMENT SEATS

The procedures relating to the final phase of allotment for MBBS/BDS Courses 2009 have started on **11.09.2009**. Accordingly, candidates can re-arrange/delete their existing higher order options **till 1 pm on 15.09.2009** at www.cee.kerala.gov.in

Candidates who have already taken admission for MBBS/BDS Courses in Self-financing Medical/Dental Colleges, but, if not interested in continuing the course, shall cancel their admissions on or before **16.09.2009**. There will not be any provision to cancel the admission from Self-financing Medical/Dental Colleges after **16.09.2009**. The authorities of Self-financing Medical/Dental Colleges shall inform the Commissioner for Entrance Examinations, in writing, the vacancies available in their institutions on or before **5 pm on 16.09.2009**.

Candidates who are not interested in pursuing studies in Self-financing Medical/Dental Colleges shall not retain any options to these institutions. They will have to cancel all their options to these institutions on or before 1 pm on 15.09.2009 through their home pages. Final Allotment to MBBS/BDS courses will be published on 18.09.2009 and those receiving allotment shall remit the requisite fee in the selected branches of SBT from 18.09.2009 to 22.09.2009 and join the Colleges on 22.09.2009 itself. There will not be any further allotment to Self-financing Medical/Dental Colleges after 18.09.2009.

It has come to the notice that every year a few Government seats are lost due to the unnecessary filing of options. Students who file unwanted options and do not join subsequently on allotment, are blocking the chances of other deserving students. Liquidated damages will be levied from such students. Their candidature and rank in the Entrance Examination will also be cancelled.

The final date for Cancellation of admission from Government Medical/Dental Colleges will be **23.09.2009**.

If any vacancies arise in Government Medical/Dental Colleges after the allotment on 18.09.2009, an exclusive allotment to these seats in Government Medical/Dental Colleges will be published on 23.09.2009. For this, the options of candidates as on 15.09.2009 will be considered. Candidates who get allotment at this final stage, shall be bound to join the allotted institutions on or before 30.09.2009 and continue their studies. If not, they will be liable to pay the liquidated damages.
