ORDER

Government have issued orders specifying the terms and conditions regarding the admission to MBBS and BDS courses for the academic year 2013-14. As per the letter read above, the Commissioner for Entrance Examinations has reported that approximately 23 seats (14 MBBS and 9 BDS seats) are vacant in Government Medical/Dental Colleges. As per the consensual agreements entered into with the Private Self Financing Institutions, the last date for filling up of the Government Merit quota seats was 20th day of September 2013. As such Government cannot allot students to the Self Financing institutions in the vacant Merit Quota seats after the cut off date. But there are chances of requests from the students already admitted in the Self Financing institutions for re-allotment to vacant seats in Government Medical/Dental Colleges and it will create lapsing of Government Merit quota seats in Self Financing institutions. Hence the Commissioner for Entrance examination has

requested to issue guidelines for allotment of vacant MBBS/BDS seats in Government Medical/Dental Colleges.

- 2. Government have examined the matter in detail and are pleased to issue the following orders.
 - a) The Commissioner for Entrance examinations shall allot students from the Merit list who have already filed options for filling up of the vacant MBBS/BDS seats in Government Medical/Dental Colleges.
 - b) The Commissioner for Entrance Examinations will not re-allot students already allotted and admitted in a Self Financing College by the Commissioner for Entrance Examinations on or before 20.09,2013.
 - c) The admissions made to the vacant MBBS/BDS seats in Government Medical/ Dental Courses shall be subject to the outcome of any litigation before any Court of Law.
