## <u>ORDER</u>

Government have issued the prospectus for admission to Professional Courses-KEAM.13 as per the G.O read above. The following amendments are made to the Prospectus:

In addition to the existing Para 6.2.2(a), the following provisions are hereby incorporated to the Prospectus, as "Para 6.2.2(a) (i) The candidates who have passed Higher Secondary Examination, Kerala or Examination as equivalent thereto, with 60% aggregate marks in Physics and Chemistry put together and 45% marks in Mathematics are also eligible for admission. (In case the candidate has not studied Chemistry, the marks obtained in Computer Science shall be considered. In case the candidate has not studied Chemistry and Computer Science, the marks obtained in Biotechnology shall be considered. In case, the candidate has not studied Chemistry, Computer Science and Biotechnology, the marks obtained in Biology shall be considered.)" and as "Para 6.2.4(b) (i) For the SEBC candidates and PD candidates who come under Para 6.2.2(a) (i), 55% aggregate marks for the optional subjects put together is sufficient. They need only 40% marks in Mathematics"

The SC/ST candidates need only a pass in the qualifying examinations. There is no change in **Para 6.2.3** of the **Prospectus**.
