**SECOND PHASE OF ALLOTMENT TO POST GRADUATE MEDICAL
DEGREE/DIPLOMA COURSES, KERALA - 2018**
FACILITY FOR ONLINE OPTION REGISTRATION/DELETION/REARRANGEMENT AVAILABLE

The activities related to the second phase of Single Window System of allotment to Post Graduate Medical Degree/Diploma Courses for the year 2018 will commence on 19/04/2018. The vacant/enhanced seats in Government Medical Colleges and the seats in Self-financing Medical Colleges including NRI and Minority Community quota seats shall be filled in this phase of allotment.

The allotment will be subject to the conditions and provisions in GO(Rt) No. 1218/2018/H&FWD dated 12.04.2018. Accordingly, a revised rank list will be published by including qualified Service candidates who have served in rural areas after giving the mark incentive for the period of eligible service. The allotment shall be based on the revised rank list thus prepared. But the allotment of those candidates who have already taken admission during the first phase of allotment will be protected.

All the candidates in the revised rank list can register fresh options to the newly included courses/colleges as well as to those courses/colleges not opted in the first phase. The candidates who have already received an allotment in the 1st phase and joined in the course/college allotted can re-arrange/delete their existing higher options and also register fresh options. Candidates who have not received any allotment in the first phase can also re-arrange/delete their existing options and also register fresh options. The facility for online option registration/deletion/re-arrangement shall be available in the website www.cee.kerala.gov.in from 19/04/2018 to 24/04/2018, 3 pm.

Online Option confirmation is mandatory

The candidates who have received an allotment in the first phase and joined in the course/college allotted and also the candidates who have not received any allotment in the first phase who want to be considered for the second phase of allotment shall have to confirm their options online by clicking the 'Confirm' Button available in the Home page of the candidate. Those who do not confirm their options online will not be considered for the second phase of allotment for the existing options.

Conditions of exit after second phase of allotment

Those candidates who have joined PG course both in All India as well as State quota on exit, after being allotted to the seats in the second round will have to forfeit 10% of the annual fee if they do not join the course i.e., the exit shall be allowed on forfeiture of 10% of the total annual fee during the second round and if they have joined the course they will not be eligible for further counseling. In case the applicant retains the seats in the first allotment and he/she is not allotted any seats in the second allotment then this allotment in the first allotment will be considered as equivalent to the seat allotted in second round and he will have to forfeit 10% of annual fee, if he decides to quit before the last date of surrender of seat already allotted.

The schedule for the second phase of allotment is given below:

19/04/2018	Website opens for enabling re-arrangement / deletion of existing higher options and for registering fresh options
24/04/2018, 3 pm	Facility for re-arrangement / deletion / registration of options ends.
26/04/2018	Publication of second phase of allotment

27/04/2018-03/05/2018	All candidates who get an allotment shall remit the fee / balance fee by online payment as shown in the allotment memo.
27/04/2018-03/05/2018	All candidates should join the course and college to which they are allotted along with the required documents and Fee Receipt.
03/05/2018, 5pm	College authorities to approve and submit the list of admitted candidates through Online Admission Management System (OAMS)

Candidates allotted to courses, and who remit the fee/balance fee as prescribed, should take admission in the college/course allotted as per the schedule prescribed by the CEE. No extension of time for reporting to the college will be granted under any circumstances. The candidates are liable to pay admission fee as prescribed by the University concerned at the time of admission.
