**ORDER**

The following guidelines are issued for effecting the counselling and allotment of post graduate Medical & Dental courses and super speciality courses in Self Financing Colleges under the Kerala Christian Professional College Management Federation for the academic year 2017-18 in the light of the supreme court order on common counselling and subsequent admission to the minority institutions.

- 1.Community seats in the Management Colleges will be open for all Christians who submit a certificate by the Parish priest or Paster in a common format, and the same should be approved by the representative of the Management.
2. The CEE will enable the applicant to upload the said signed proforma to add to their application.
- 3.Based on the uploaded certificates CEE will prepare a common ranklist at the time of counselling which will be verified by the representative of the concerned college who is authorised by the Principal.
- 4.Merit list will be prepared based on the NEET rank, choice of the specialty and interse merit of the respective college.
- 5.Specialty wise list will be available online before counselling.
- 6.Seperate options to be invited for NRI quota and ranklist will be prepared as per the interse merit within the NRI quota



7.The following copies of the documents are to be uploaded along with the application in respect of NRI quota.

- a) Relationship certificates of the sponser and student to be issued by the revenue authorities as per G.O (Ms.) 193/2013/H&FWD
- b) Overseas employment certificate issued by the employer attested by the Embassy and if self employed it should also be attested by the Embassy.
- c) Passport with visa stamped on it attested by the Embassy.
- d) A self Affidavit of the relationship between sponsor and the candidate.
- e)The Sponsor should be an Indian citizen or overseas citizen of Indian origin.

8.The Management should provide the seat distribution as open seat (General, SEBC&SC/ST), Community seats and NRI seats for each subject.

9.The College authorities shall forward the seat metrics and university affiliation for each course.

10.The following are the schedule for allotment and admission.


