**SIXTH PHASE OF CENTRALIZED ALLOTMENT TO
PROFESSIONAL DEGREE COURSES 2010**

The Sixth phase of Allotment for KEAM 2010 will be published on 19.09.2010. Facilities will be available on the website www.cee.kerala.gov.in for candidates to re-arrange or delete options from 10 am to 5 pm on 17.09.2010.

Candidates who get allotment in the Sixth allotment should remit fee/balance fee at designated branches of State Bank of Travancore (SBT) on September 20th, 22nd or 23rd and report for admission in the respective Colleges on September 22nd or 23rd.

It was previously notified that candidates who received allotment as per Fifth allotment in Medical/Dental Colleges should remit the fees on 14th or 15th of September and take admission on 15th or 16th of September in respective Colleges. However, those candidates who received allotment in Private Self-financing Medical Colleges need only report for admission in the respective Colleges on 22nd or 23rd September based on the Sixth allotment to be published on 19th September 2010.

The MBBS seats in Private Self-financing Medical Colleges/seats for Engineering/Ayurveda/Siddha/Homoeo and seats in colleges under the Kerala Agricultural University which remained vacant as a result of non-payment of fees on September 14th or 15th in the Fifth phase of allotment will be allotted during the Sixth allotment.

Schedule for Sixth Allotment is shown below :

17.09.2010 (from 10 am to 5 pm)	Website opens for Sixth Allotment providing facility to re-arrange or delete existing higher options.
19.09.2010	Sixth Allotment
20.09.2010, 22.09.2010 & 23.09.2010	Candidates allotted to all courses should remit fee/balance fee/deposit at the selected branches of the State Bank of Travancore (SBT)
22.09.2010 & 23.09.2010	Candidates who receive allotment for all Courses to report for admission in Colleges based on Sixth Allotment.
24.09.2010	All Colleges to furnish non-joining report to CEE.

Important points to be noted in the Sixth Phase of Allotment :

1. Candidates who are satisfied with the allotment received in the Fifth allotment should cancel their existing higher order options. Candidates can cancel their higher options through their home page only.
2. Candidates who retain unnecessary options to Colleges/Courses and eventually do not take admission on allotment, thereby lapsing Government seats and spoil the opportunity of other students for studies in Government seats, will be liable for penalties as envisaged in clause 12.2.4 (c) of the Prospectus. Their candidature is liable to be cancelled.
3. There will not be any provision for Cancellation of Allotment/re-allotment received in Medical/Dental Colleges. Hence candidates are directed not to retain any unnecessary options.

Candidates shall visit the Official Website of the Commissioner for Entrance Examinations, cee-kerala.org for authentic information relating to allotment and remittance of fee.
