Government having examined the matter in detail are pleased to order that the last date, for those students who are eligible for the exemption from the payment of liquidated damages as per the G.O read as 4th papers above, for joining MBBS/BDS courses in all the Private Self Financing Medical/Dental Colleges, including the colleges under Kerala Christian Professional College Managements' Federation & Dr. Somervell Memorial CSI Medical College, Karakonam, without paying the liquidated damages, will be 20/09/13.
