ORDER

Government have issued orders vide G.O read as fourth paper above, fixing the fee structure for B.Arch course in Self Financing Architecture Colleges in the State for admission for the academic year. 2013–14. As per the said G.O the students who are admitted to the Private Self Financing Architecture Colleges based on the allotment by the Commissioner for Entrance Examinations under the “ 25% Others ” category are required to pay “Yearly Tuition fee” of Rs.40,000/- (Rupees forty thousands only) and “Yearly Special Fee” of Rs.30,000/- (Rupees thirty thousands only).

Government are pleased to order that the fee structure for the students who come under the said category of “ 25% Others ” mentioned in the G.O read as fourth paper above, will be: “Yearly Tuition fee” of Rs.40,000/- (Rupees forty thousands only) and “Yearly Special Fee” of Rs.25,000/- (Rupees twenty five thousands only) ie such students are required to pay Rs.25,000/- (Rupees twenty five thousands only) as “Yearly Special Fee” instead of “Yearly Special Fee” of Rs.30,000/- (Rupees thirty thousands only) prescribed as per the G.O read as forth paper above. The fee structure fixed for B.Arch course for admission for the academic year 2013-14. vide the G.O read as fourth paper above and hereby modified is applicable to the B.Arch courses conducted by

the Private Self Financing Architecture Colleges only and not applicable to the B.Arch courses conducted by the Private Self Financing Engineering Colleges. The G.O read as fourth paper above is modified to this extent only.


