ORDER

In the circumstances reported by the Commissioner for Entrance Examination in his letter read above, Government are pleased to approve the following guidelines for the Spot allotment in PG Medical/Dental courses during 2017-18 in addition to the guidelines stipulated in clause 10.1.18 of the Prospectus for admission to PG Medical Course 2017 and Clause 11.A (xix) of the Prospectus for admission to PG Dental Course 2017.

- The Spot Admission will be based on the Revised Combined Rank list to be published.
- 2. The transfer from the NRI quota seats to Community or General Quota seats are permitted.
- 3. The newly registered candidates are permitted only in minority seats and NRI seats in Private Self Financing Colleges seats and seats in Deemed Universities. The claim of the candidates registered newly consequent to the relaxation in qualifying criteria in NEET PG 2017 to the Government seats shall be subject to the verification and satisfaction of documents in proof of the same, at the time of spot admission.
- 4. Candidates (except SC/ST) getting fresh admission to any Government Medical Colleges through spot allotment shall have to produce a Demand Draft for ₹ 45,000/- drawn in favour of Commissioner for Entrance Examinations, payable at Thiruvananthapuram at the time of allotment. A candidate getting

fresh allotment in Private Self Financing Medical/Dental Colleges/Deemed University shall have to remit ₹2,00,000/- by way of Demand Draft drawn in favour of Commissioner for Entrance Examinations, payable Thiruvananthapuram. Remaining fees shall have to be remitted in the allotted college.

- 5. The candidates except those who are allotted and admitted by Commissioner for Entrance Examinations shall have to produce originals of all documents mentioned in Clause 10.2 of the Prospectus for admission to PG Medical course 2017 and Clause 11.C of the Prospectus for admission to PG Dental courses 2017 including Transfer Certificate.
- 2. Government Orders read above stand modified to this extent.
