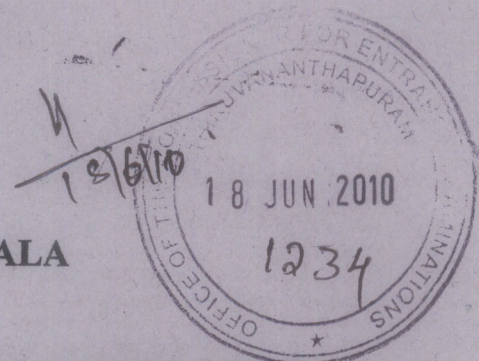

ORDER

As per the Government Order 2nd and 3rd cited Government introduced the Tuition Fee waiver Scheme for Women, Economically backward and physically handicapped meritorious students during the 2009-10. The Commissioner for Entrance Examinations in his letter read as 4th paper above requested to Government that, in order to implement the Tuition Fee waiver Scheme during 2010-11, 10% seats have to be increased in all courses in all Government, Government Aided, Government controlled Self-financing Engineering Colleges.

Government examined the matter in detail and are pleased to accord sanction for implementing the Tuition Fee Waiver Scheme for Women, Economically backward and physically handicapped meritorious students with an additional intake of 10% seats in all courses in all Government, Government Aided, Government controlled Self-financing Engineering Colleges including LBS Centre, IHRD, CAPE, Sree Chitra Thirunal College of Engineering, Centre for Continuing Education Kerala, Colleges under Universities etc., for the year 2010-11 for implementing Tuition Fee Waiver Scheme introduced by AICTE. The additional intake is sanctioned subject to the following conditions;

- (i) The Colleges that opt for the scheme shall implement the Tuition Fee Waiver Scheme as per the conditions laid down by the AICTE in the guidelines dated 09/04/2007 and letter dated 16/04/2007.
- (ii) The Colleges will publish the matter through the website and or otherwise invite applications for enrolment based on parameters fixed by AICTE.
- (iii) The Colleges will provide to the Commissioner for Entrance Examinations, the complete details of students thus admitted and this information will also be put up on the website.
- (iv) The Colleges shall furnish the details of admissions made under the Tuition Fee Waiver Scheme to Government also.

The Commissioner for Entrance Examinations will watch the compliance of the conditions in the guidelines and the letter of AICTE by the institution concerned.
